# Report from President

Peyto Exploration & Development Corp. ("Peyto" or the "Company") is pleased to report its operating and financial results for the second quarter of 2026.

## Q2 2026 Highlights:

- Peyto delivered second quarter production volumes of 145,320 boe/d (758.2 MMcf/d of natural gas, 18,959 bbls/d of NGLs), a 10% increase year over year (7% on a per share basis), driven by the Company's successful capital program.
- Funds from operations<sup>1,2</sup> ("FFO") of \$227.7 million (\$1.09/diluted share, up 15%) was recorded, and \$140.6 million of free funds flow<sup>3</sup> was generated in the quarter. Strong FFO was driven by the Company's industry-leading low cash costs<sup>4</sup> and realized natural gas price after hedging and diversification activities of \$3.42/Mcf, 108% higher than the AECO 7A monthly benchmark.
- Adjusted earnings<sup>5</sup> (earnings excluding unrealized gains or losses on financial instruments and foreign exchange) for the quarter totaled \$105.0 million, or \$0.50/diluted share, and rose 19% from \$0.42/diluted share in Q2 2025.
- The Company returned \$71.8 million of dividends to shareholders in the quarter and reduced net debt<sup>6</sup> by \$72.4 million from March 31, 2026.
- Peyto recorded \$36.7 million in realized hedging gains in the quarter and has a hedge position protecting approximately 505 MMcf/d of natural gas production for the second half of 2026 and 404 MMcf/d for 2027, at \$4.02/Mcf and \$3.31/Mcf, respectively. The Company's natural gas and NGL hedges combine to secure revenue of approximately \$485 million for the second half of 2026 and \$590 million for calendar 2027, thus far.
- The Company bolstered its diversification program with the signing of a long-term natural gas supply agreement with Centrica Energy ("Centrica"). Under the agreement, Peyto will deliver 50,000 MMBtu/d to Centrica over a 10-year period commencing in 2029. Deliveries will be made at the NIT (AECO) hub and will be priced against the Dutch Title Transfer Facility ("TTF") benchmark, less deductions.
- A 71% operating margin<sup>7</sup> and a 29% profit margin<sup>8</sup> were generated in the quarter, resulting in an 18% return on capital employed<sup>9</sup> ("ROCE") and a 16% return on equity<sup>9</sup> ("ROE"), on a trailing 12-month basis.
- Cash costs<sup>10</sup> totaled \$1.32/Mcfe in the quarter, including \$0.28/Mcfe of royalties. Cash costs before royalties totaled \$1.04/Mcfe, 11% lower than Q2 2025 and back to levels prior to the Company's acquisition of the Repsol Assets in Q4 2023. These costs included operating expense of \$0.50/Mcfe, transportation of \$0.30/Mcfe, G&A of \$0.05/Mcfe and interest expense of \$0.19/Mcfe.
- Capital expenditures totaled \$84.9 million in the quarter. Peyto drilled 10 wells (10.0 net), completed 14 wells (14.0 net), and brought 15 wells (15.0 net) on production. Additionally, the Company purchased 26 gross (26 net) sections of undeveloped land through crown land sales and mineral land acquisitions bringing H1 2026 total mineral land acquisitions to 67 gross (53.8 net) sections.

## Second Quarter 2026 in Review

Peyto slowed capital activity in the quarter during a wet spring and early summer period. Second quarter production averaged 145,320 boe/d, up 10% year over year. The AECO 7A monthly gas price averaged only \$1.43/GJ during the quarter, however, Peyto's diversification to downstream markets and mechanistic hedging strategy helped to achieve a realized natural gas price of \$3.42/Mcf (\$2.97/GJ), more than double the AECO price. The Company continued to add to the diversification portfolio with a 50,000 MMBtu/d natural gas supply agreement linked to European TTF pricing starting in 2029. At the start of the quarter, Peyto began delivering approximately 85 MMcf/d of sales gas to a third-party processor which has enhanced NGL

recoveries by an incremental 1,500 bbls/d. Strong production and realized pricing during the quarter, combined with Peyto's lowest controllable costs since acquiring the Repsol assets, contributed to FFO of \$227.7 million, up 19% (15% per diluted share) from Q2 2025. The FFO supported \$84.9 million of capital expenditures, \$71.8 million of shareholder dividends and allowed for a \$72.4 million reduction in net debt in the quarter.

## Capital Expenditures

Peyto spud 10 gross (10.0 net) horizontal wells in the second quarter, including 3 Cardium, 1 Notikewin, 3 Falher, and 3 Wilrich wells in the core Sundance and Brazeau areas as the Company slowed drilling activity through the traditional wet break-up period. Despite slower drilling, Peyto managed to complete 14 gross (14.0 net) wells and brought 15 gross (15.0 net) wells on production in the quarter, resulting in total well-related capital expenditures of \$67.8 million. As part of the program, Peyto spud the first well on a three-well Cardium pad in Sundance that will test the extended reach design which has proven to be successful in Brazeau, improving capital efficiencies for the play. Additionally, Peyto invested \$13.6 million in facilities, pipeline optimization projects, and turnarounds at the Kakwa, Cecilia and Brazeau gas plants. Drilling costs per meter increased 17% as compared to Q1 2026, as Peyto drilled shorter laterals in Spirit River channels in the quarter and ran into isolated operational problems on two wells that resulted in higher average per well drill costs. Completion costs per meter were up marginally from Q1 2026 due to species mix. Peyto's historical drilling and completion costs are summarized in the following table.

To further bolster drilling inventory, Peyto successfully acquired 26 gross (26 net) sections in the Company's core areas through crown land sales and mineral land purchases totaling \$1.9 million. This includes 14 sections in the Brazeau area targeting recent Cardium success and brings the total capital invested on land acquisitions and new inventory in the first half of 2026 to \$5.5 million to acquire 67 gross (53.8 net) sections at average cost of \$158/acre.

Peyto also spent \$2.2 million towards abandonment and reclamation activities during the quarter as part of the planned \$13 million budget for 2026.

## Marketing

### Commodity Prices

In the second quarter, Peyto realized a natural gas price after hedging of \$3.42/Mcf, or \$2.97/GJ, 108% higher than the average AECO 7A monthly benchmark of \$1.43/GJ, driven by strong realized prices at the Company's non-AECO hubs, including Dawn, Parkway, Ventura, Chicago and Henry Hub, as well as realized hedging gains. Peyto's diversification activities contributed \$0.93/Mcf (net of diversification costs) in the quarter, while the Company's natural gas hedging activity resulted in a realized gain of \$0.85/Mcf (\$58.1 million). The value of Peyto's natural gas market diversification and hedging activities over the past eight quarters, relative to the AECO 7A benchmark, is illustrated in the following table.

Condensate and pentanes averaged \$125.42/bbl for the quarter, up 54% year over year driven by higher WTI oil prices from escalating geopolitical tension in the Middle East. Other NGL volumes were sold at an average price of \$28.48/bbl, or 22% of Canadian dollar WTI. Peyto's combined realized NGL price was \$77.40/bbl before hedging, and \$64.98/bbl including a realized hedging loss of \$12.42/bbl (\$21.4 million) in the second quarter of 2026.

During the quarter, the Company entered into a long-term natural gas supply agreement with Centrica. Under the agreement, Peyto will deliver 50,000 MMBtu/d to Centrica over a 10-year period commencing in 2029. Deliveries will be made at the NIT (AECO) hub operated by NGTL in Alberta. The natural gas will be priced against the Dutch TTF benchmark, less deductions. With this new agreement, Peyto has over 400 MMcf/d of natural gas exposed to non-AECO markets starting in 2028 and beyond. The diversification portfolio includes physical or financial agreements that are linked to markets at Dawn/Parkway, Chicago/Ventura, Henry Hub, Empress, Emerson 2, Dutch -TTF, and Alberta power prices. Natural gas at these markets can be hedged to secure revenue or left to float on daily or monthly prices.

### Hedging

The Company has been actively hedging future production with financial and physical fixed price contracts to protect a portion of its future revenue from commodity price and foreign exchange volatility. The following table summarizes Peyto's hedge position for the second half of 2026, calendar 2027 and calendar 2028. Peyto's natural gas and liquid hedging program has secured revenue of approximately \$485 million for the second half of 2026 and \$590 million for calendar 2027.

The Company's fixed price contracts combined with its diversification to the Cascade power plant and other premium market hubs in North America allow for revenue security and support Peyto's capital expenditure program, continued shareholder dividends and debt reduction. ### Netbacks

The Company's realized natural gas and NGL sales yielded a combined revenue stream of \$3.92 /Mcfe before hedging gains of \$0.46/Mcfe, resulting in a quarterly net sales price of \$4.38/Mcfe, 3% higher than the \$4.27/Mcfe realized in Q2 2025. Cash costs totaled \$1.32/Mcfe in the quarter, 1% higher than \$1.31/Mcfe in Q2 2025 due to increased royalties. Cash costs before royalties decreased 11% from Q2 2025 and have been reduced to levels prior to the acquisition of Repsol Assets in Q4 2023, achieving Peyto's strategy to fully integrate the assets into the Company's low-cost model. Operating costs totaled \$0.50/Mcfe, down from \$0.54/Mcfe in Q2 2025 while interest costs totaled \$0.19/Mcfe, down from \$0.26/Mcfe in Q2 2025. The Company's cash netback (net sales price including other income, net marketing revenue, realized gain on foreign exchange, less total cash costs) was \$3.16/Mcfe, resulting in a solid 71% operating margin. Effective April 1, 2026, Peyto entered into a new agreement with a midstream operator to process natural gas at its deep cut facility from certain gas plants in the Sundance area. Since then, The Company has been delivering approximately 85 MMcf/d of sales gas and generated approximately 1,500 barrels per day of incremental Propane, Butane, and Pentanes+ volumes.

Depletion, depreciation, and amortization charges of \$1.28/Mcfe, along with provisions for current tax, deferred tax, performance-based compensation and stock-based compensation resulted in earnings of \$1.31/Mcfe, for a 29% profit margin. Dividends to shareholders totaled \$0.91/Mcfe.

## Activity Update

Drilling activity has picked up after spring breakup with a total of 4 rigs active in the Sundance and Brazeau core areas. Since the end of the second quarter, 9 gross (9 net) wells have been spud, 7 gross (7 net) wells have been completed, and 6 gross (6 net) wells have been brought on production. The Company expects to continue operating 4 drilling rigs for the balance of the year but will react to changing commodity prices and the business environment as necessary.

Peyto has continued developing Cardium prospects with an updated drilling and completion design. Drilling longer laterals and increasing completion intensity to improve deliverability while managing costs is key to this strategy. Recent well results in the Brazeau area have produced initial rates between 4 to 6 MMcf/d accompanied by NGL yields of up to 100 bbls/MMcf. At the same time, drilling cost reductions of 37% per horizontal meter have been achieved. This has provided the confidence to acquire additional mineral rights in the area where the Company sees at least 20 future locations to develop. Peyto has spud 5 wells in Brazeau so far in 2026 and plans to apply similar design changes to Cardium locations in the Sundance area for the remainder of the year. The strategy to add more liquid-rich targets to capture higher liquid pricing in 2026 also serves to improve economic returns for the long-term benefit of Cardium inventory across the Company's core areas.

To date in 2026, Peyto has completed turnarounds at four of its 13 operating gas plants and has one more planned on a portion of the Swanson Gas Plant later this August. These scheduled plant disruptions have minimal effect on corporate production due to the interconnectivity of the Company's gas gathering system, a feature of Peyto's "own and control" strategy that is core to the Company's operations that goes beyond low cost operations. This integrated system allows production volumes to be rerouted during maintenance periods, minimizing the impact on production. Peyto also attempts to coordinate these turnarounds with other downstream maintenance activities (for example on NGTL or at fractionation facilities) to minimize overall production downtime. The Company controls 98% of its production which minimizes exposure to potentially lengthy third-party facility turnarounds.

## Outlook

While liquids pricing is affected by ever-changing world events, natural gas demand continues to grow, and the outlook remains positive both within Alberta and globally. The prospect of continued LNG buildout in both Canada and the US to supply global markets and gas-fired power demand in North America, provides exciting tailwinds for the natural gas industry. However, the volatility in near-term commodity prices is a reminder of the importance of controlling costs and managing risks. Fortunately, Peyto's low risk capital plans have been protected through market diversification, a mechanistic hedging program, and an industry-leading cost structure. The Company re-iterates its 2026 capital program to invest between \$450 to \$500 million to add 43,000 to 48,000 boe/d of new production by yearend. In the meantime, Peyto will manage production to limit exposure to weaker priced markets for the remainder of the summer season, if necessary.

### Barrels of Oil Equivalent

To provide a single unit of production for analytical purposes, natural gas production and reserves volumes are converted mathematically to equivalent barrels of oil (BOE). Peyto uses the industry-accepted standard conversion of six thousand cubic feet of natural gas to one barrel of oil (6 Mcf = 1 bbl). The 6:1 BOE ratio is based on an energy equivalency conversion method primarily applicable at the burner tip. It does not represent a value equivalency at the wellhead and is not based on current prices. While the BOE ratio is useful for comparative measures and observing trends, it does not accurately reflect individual product values and might be misleading, particularly if used in isolation. As well, given that the value ratio, based on the current price of crude oil to natural gas, is significantly different from the 6:1 energy equivalency ratio, using a 6:1 conversion ratio may be misleading as an indication of value.

### Thousand Cubic Feet Equivalent (Mcf)

Natural gas volumes recorded in thousand cubic feet (mcf) are converted to barrels of oil equivalent (boe) using the ratio of six (6) thousand cubic feet to one (1) barrel of oil (bbl). Natural gas liquids and oil volumes in barrel of oil (bbl) are converted to thousand cubic feet equivalent (Mcf) using a ratio of one (1) barrel of oil to six (6) thousand cubic feet. This could be misleading, particularly if used in isolation as it is based on an energy equivalency conversion method primarily applied at the burner tip and does not represent a value equivalency at the wellhead.

### Non-GAAP and Other Financial Measures

Management believes that by excluding the temporary impact of changes in non-cash operating working capital, funds from operations provides a useful measure of Peyto's ability to generate cash that is not subject to short-term movements in operating working capital. The most directly comparable GAAP measure is cash flows from operating activities.

#### Free Funds Flow

Peyto calculates free funds flow as cash flows from operating activities before changes in non-cash operating working capital, provision for performance-based compensation, and transaction costs, less total capital expenditures, allowing Management to monitor its free funds flow to inform its capital allocation decisions. "Funds from operations" is a non-GAAP financial measure. Management believes that funds from operations per share provides investors an indicator of funds generated from the business that could be allocated to each shareholder's equity position.

**Netback per MCFE and BOE**

#### Operating Margin

Operating Margin is a non-GAAP financial ratio defined as funds from operations, before current tax, divided by revenue before royalties but including realized hedging gains/losses, other income and net marketing revenue.

#### Profit Margin

Profit Margin is a non-GAAP financial ratio defined as net earnings divided by revenue before royalties but including realized hedging gains/losses, other income and net marketing revenue.

#### Cash Costs

Cash costs is a non-GAAP financial ratio defined as the sum of royalties, operating expenses, transportation expenses, G&A and interest, on a per Mcfe basis. Peyto uses total cash costs to assess operating margin and profit margin.

#### Return on Equity (ROE)

Peyto calculates ROE, expressed as a percentage, as trailing 12-month earnings divided by period-end shareholders' equity. Peyto uses ROE as a measure of long-term financial performance, to measure how effectively Management utilizes the capital it has been provided by shareholders and to demonstrate to shareholders the returns generated over the long term.

#### Return on Capital Employed (ROCE)

Peyto calculates ROCE, expressed as a percentage, as adjusted earnings before interest and taxes ("Adjusted EBIT") on a trailing 12-month basis, divided by average capital employed over a trailing 12-month basis. Average capital employed is calculated as the average of shareholders' equity plus average net debt, over the past four quarters. In reporting ROCE for prior periods, capital employed was defined as shareholders' equity plus long-term liabilities at period end. The Company has changed the definition of capital employed to better align liabilities with interest-bearing debt. Peyto uses ROCE as a measure of long-term financial performance to measure how effectively Management utilizes the capital (debt and equity) it has been provided and to demonstrate to shareholders the returns generated over the long term. ## Management's discussion and analysis

This Management's Discussion and Analysis ("MD&A") of Peyto Exploration & Development Corp. ("Peyto" or the "Company") is Management's analysis of the financial performance and significant trends and external factors that may affect future performance. Throughout this MD&A and in other materials disclosed by the Company, Peyto adheres to IFRS® Accounting Standards (the "Accounting Standards" or "GAAP") as issued by the International Accounting Standards Board; however, the Company also employs certain non-GAAP and other financial measures to analyze financial performance, financial position, and cash flow including, but not limited to "funds from operations", "free funds flow", "total capital expenditures", "adjusted earnings" and "net debt". These non-GAAP and other financial measures do not have any standardized meaning prescribed under the Accounting Standards and therefore may not be comparable to similar measures presented by other entities. The non-GAAP and other financial measures should not be considered to be more meaningful than GAAP measures which are determined in accordance with the Accounting Standards, such as earnings (loss), cash flow from operating activities, and cash flow used in investing activities, as indicators of Peyto's performance. See "Non-GAAP and Other Financial Measures" included at the end of this MD&A for an explanation of these financial measures and reconciliation to the most directly comparable financial measure under the Accounting Standards.

### OVERVIEW

Peyto is a Canadian energy company involved in the development and production of natural gas, oil and natural gas liquids in Alberta's deep basin. At December 31, 2025, the Company's total Proved plus Probable reserves were 8.7 trillion cubic feet equivalent (1.45 billion barrels of oil equivalent) as evaluated by its independent petroleum engineers. Production is currently weighted approximately 87% to natural gas and 13% to natural gas liquids.

The Peyto model is designed to deliver a superior total return with growth in value, assets, production and income, all on a debt adjusted per share basis. The model is built around three key strategies:

- Use technical expertise to achieve the best return on capital employed through the development of internally generated drilling projects.
- Build an asset base which is made up of high-quality natural gas reserves.
- Over time, balance dividends paid to shareholders with earnings and cash flow, and balance funding for the capital program with cash flow, equity and available credit lines.

Operating results over the last 27 years indicate that these strategies have been successfully implemented.

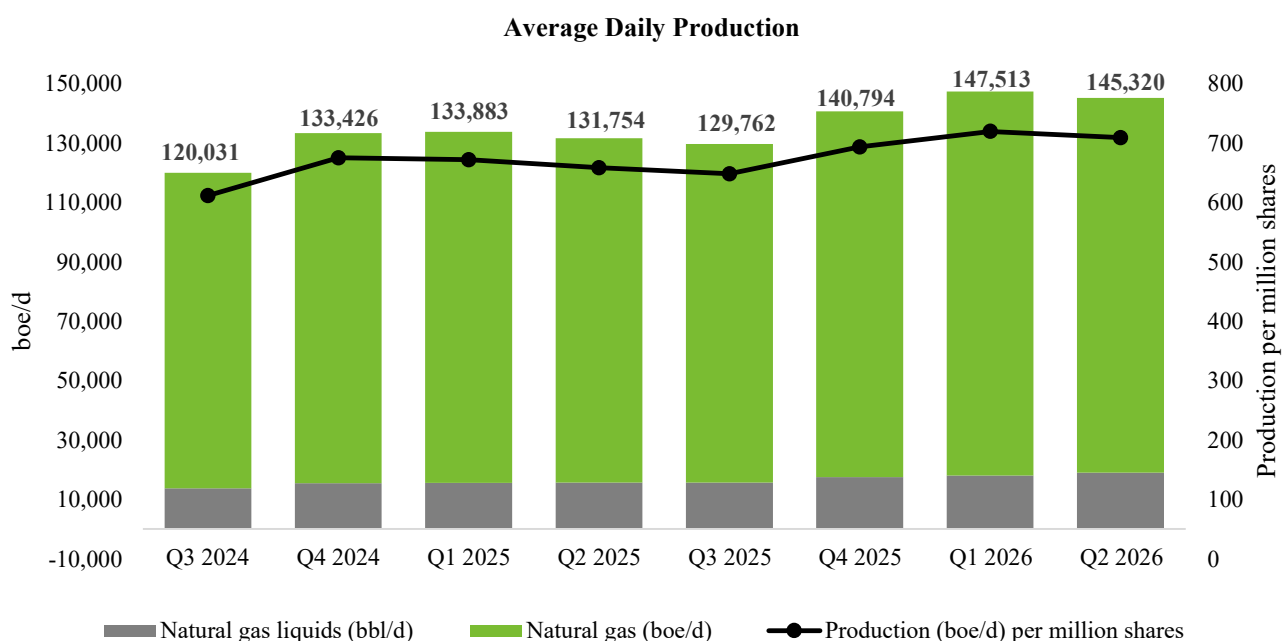

Peyto's total production for the second quarter of 2026 increased 10% to 145,320 boe/d, compared to 131,754 boe/d for the second quarter of 2025. For the first half of 2026, total production increased to 146,410 boe/d, compared to 132,812 boe/d for the same period of 2025. The increases in the three and six months ended June 30, 2026, were driven by new wells brought on production from the Company's capital program over the past year.

The liquid-to-gas ratio was 25.0 bbls/MMcf for the second quarter of 2026 compared to 22.5 bbls/MMcf for the second quarter of 2025. In the first half of 2026, the liquid-to-gas ratio increased to 24.0 bbls/MMcf from 22.1 bbls/MMcf for the same period of 2025. The increased liquid-to-gas ratio in both periods is primarily due to Peyto's capital allocation to richer formations, as well as increased NGL recoveries, to maximize overall returns with changing commodity prices.

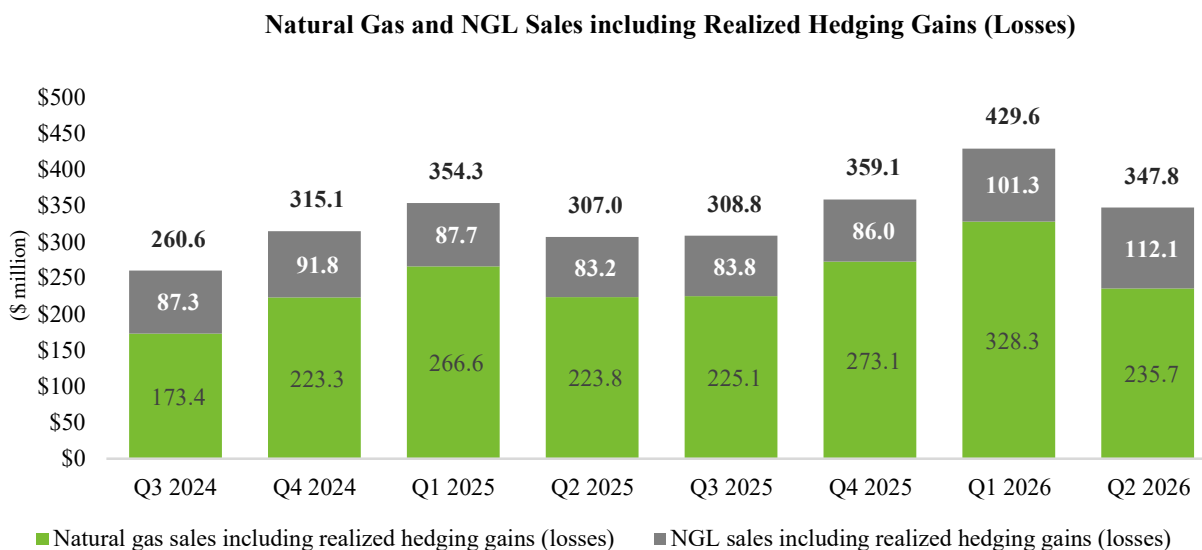

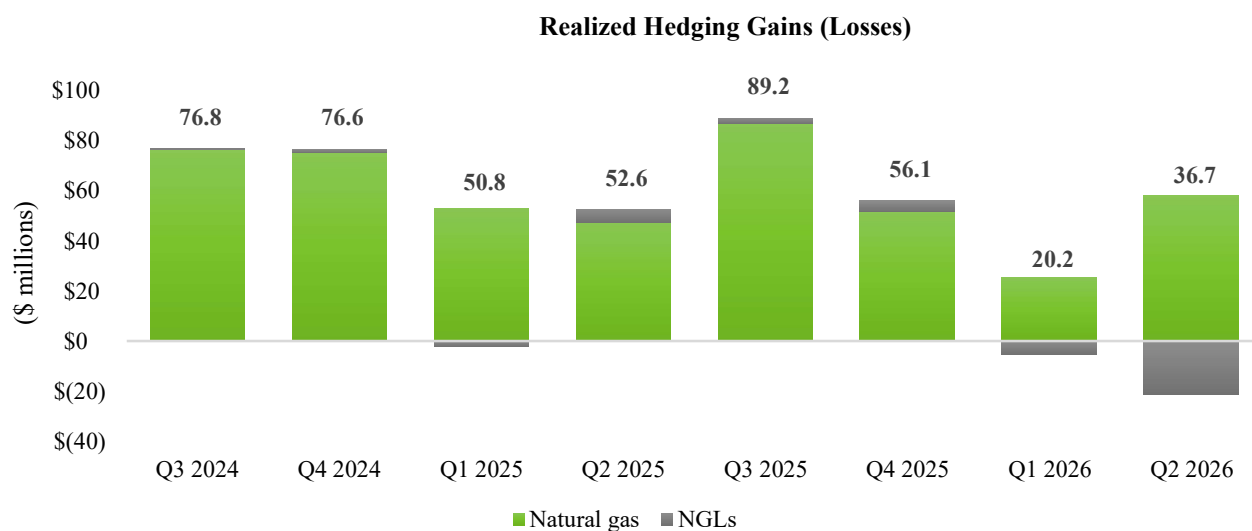
For the second quarter of 2026, natural gas and NGL sales including realized hedging gains increased 13% to \$347.8 million from \$307.0 million for the second quarter of 2025. For the six months ended June 30, 2026, natural gas and NGL sales including realized hedging gains rose 18% to \$777.4 million from \$661.3 million for the same period of 2025. The increase in the second quarter of 2026 was driven by higher production volumes and increased realized NGL prices, partially offset by lower realized natural gas prices and realized hedging gains, compared to the same periods in 2025. For the first half of 2026, the year-over-year increase was due to higher production volumes and higher realized natural gas and NGL prices, partially offset by lower hedging gains.

Peyto's natural gas and NGL sales including realized hedging gains over the past eight quarters, are summarized below.

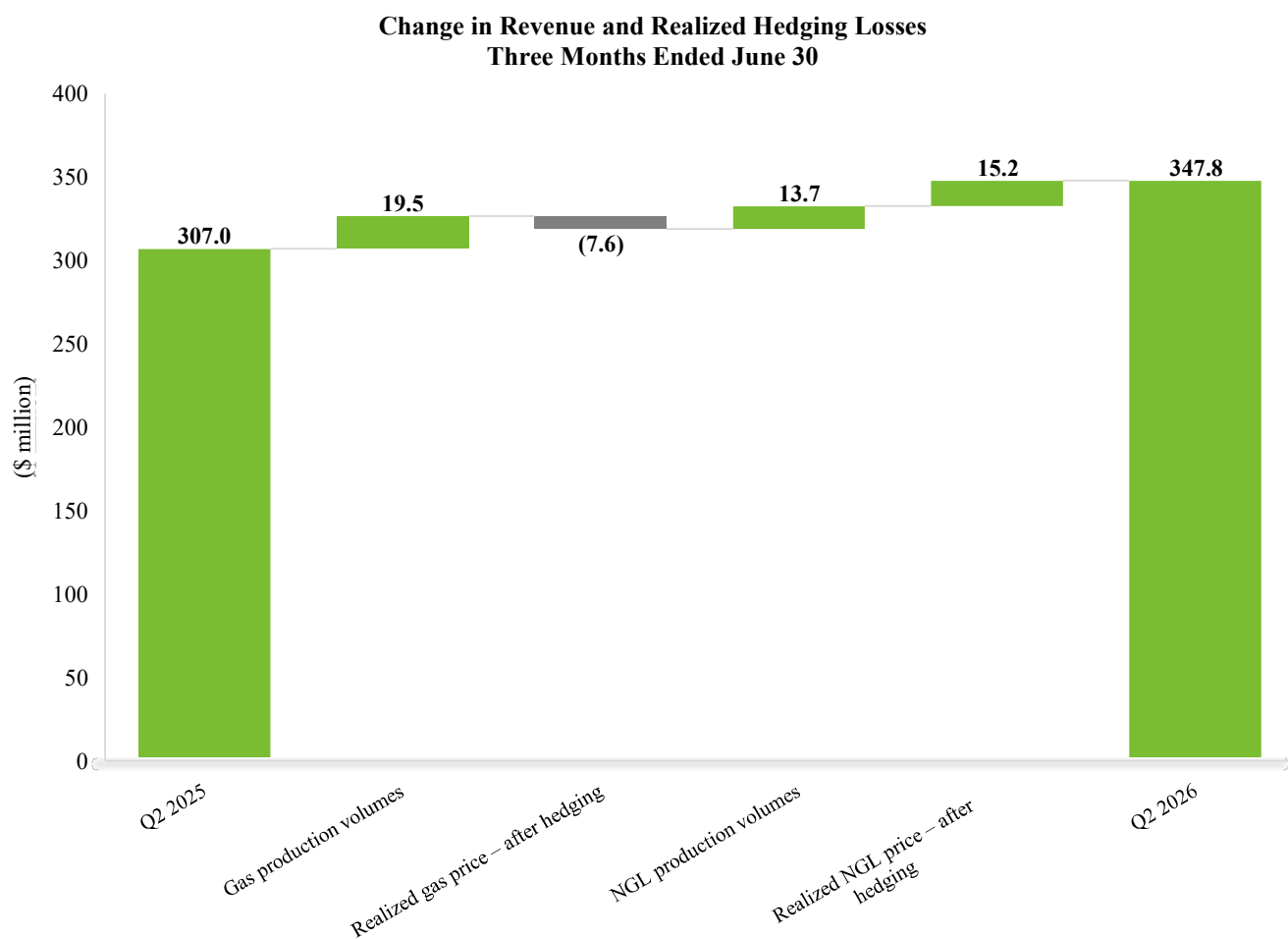


According to its commodity hedging policy, Peyto enters into risk management contracts with well-established counterparties for the purpose of protecting a portion of its future revenues from the volatility of oil and natural gas prices. In periods of increasing commodity prices, Peyto expects to realize hedging losses and in periods of falling commodity prices, Peyto expects to realize hedging gains. Peyto's hedging program since inception in 2003 has generated cumulative realized gains of \$816 million.

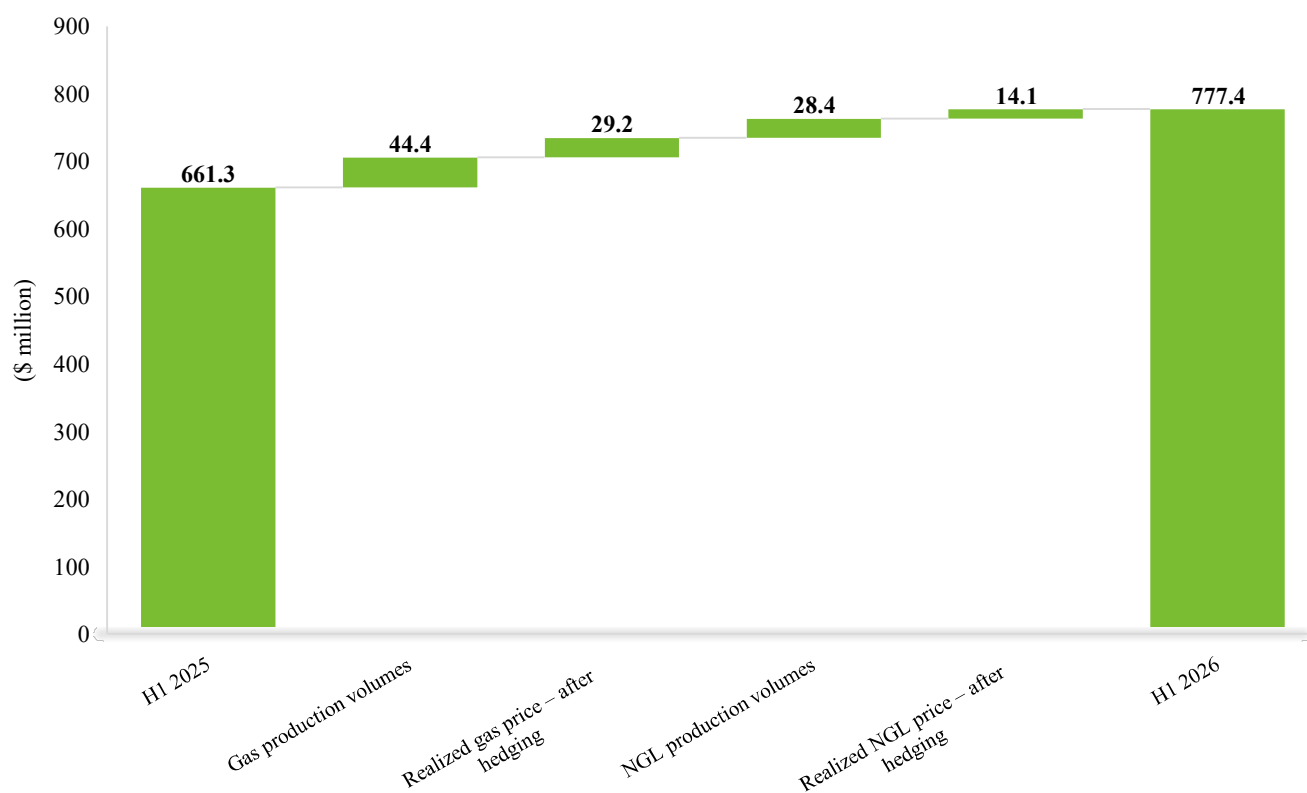

Peyto actively markets all components of its production stream including natural gas, condensate, pentane, butane and propane.

### Natural Gas Prices

Peyto's realized natural gas price, before hedging, declined 8% to \$2.57/Mcf for the second quarter of 2026 from \$2.78 /Mcf for the second quarter of 2025 due to decreased benchmark prices at all Peyto sales hubs. Peyto's realized hedging gains totaled \$0.85/Mcf for the second quarter of 2026, which rose from \$0.75/Mcf in the second quarter of 2025 due to the lower benchmark prices. The Company's realized natural gas price, after hedging and diversification, totaled \$3.42/Mcf (or \$2.97/GJ) for the quarter, 3% lower than the second quarter of 2025, but 108% higher than the AECO 7A benchmark price of \$1.43/GJ for the same period.

For the six months ended June 30, 2026, Peyto's realized natural gas price, after hedging and diversification, increased 5% to \$4.06/Mcf from \$3.85/Mcf in the same period of 2025, driven mainly from higher benchmark prices at the Company's non-AECO hubs including Dawn, Ventura, Emerson 2, Chicago, and Henry Hub, partially offset by lower realized hedging gains.

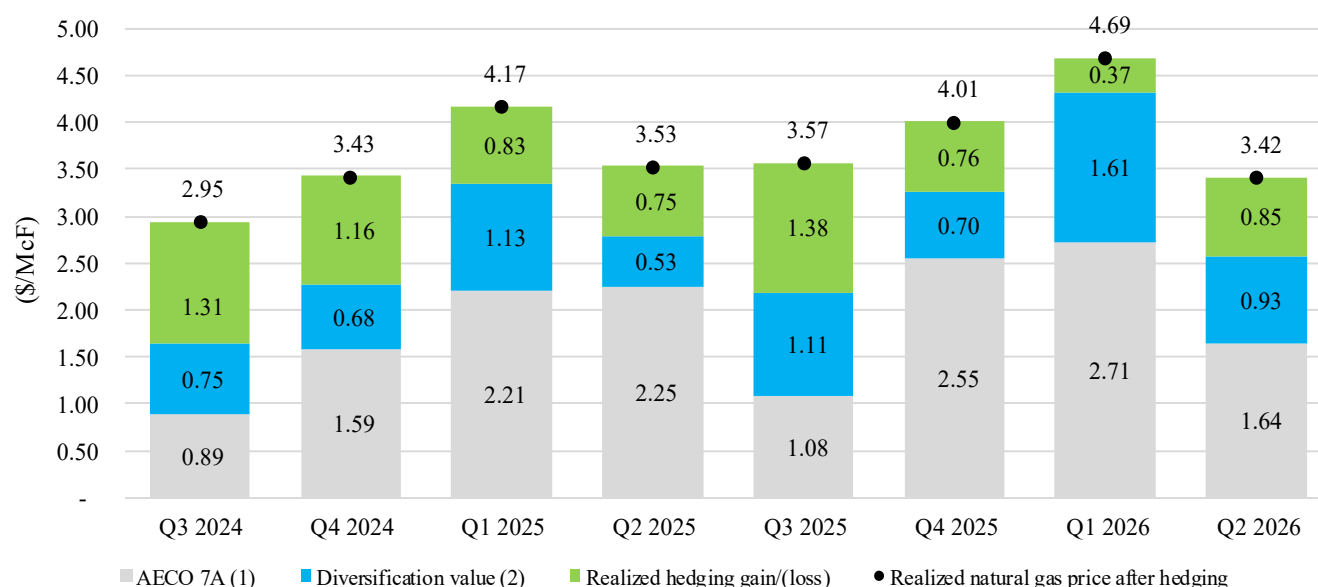
Peyto's natural gas market diversification activity resulted in natural gas sales being priced off various hubs including AECO, Ventura, Emerson 2, Malin, Dawn, Parkway, Chicago and Henry Hub using both physical fixed price and temporary basis transactions to access those locations. Natural gas prices were left to float on daily pricing or locked in using fixed price swaps at those hubs and Peyto's realized price was benchmarked against those local prices, then adjusted for marketing arrangements (either physical or short-term synthetic) to those markets.

Peyto's market diversification activity includes the 60,000 GJ/day gas supply agreement ("GSA") with the Cascade 900 MWh Combined-Cycle Power Plant. Peyto's realized price under the GSA is indexed to Cascade's realized power price.

Additionally, on June 2, 2026, Peyto announced the signing of a long-term natural gas supply agreement with Centrica Energy. Under the agreement, Peyto will deliver 50,000 MMBtu/d to Centrica Energy over a 10-year period commencing in 2029. Deliveries will be made at the NIT (AECO) hub operated by NGTL in Alberta. The natural gas will be priced against the Dutch Title Transfer Facility ("TTF") benchmark, less deductions.

The value of Peyto's natural gas market diversification and hedging activities over the past eight quarters, relative to the AECO 7A benchmark, is included in the following chart.

### NGL Prices

Peyto's realized NGL price, before hedging, rose 41% to \$77.40/bbl for the second quarter of 2026, from \$54.75/bbl for the second quarter in 2025, driven by the sharp increase in the WTI benchmark caused by Middle East geopolitical uncertainty in the quarter. WTI CAD increased 45% for the second quarter of 2026, compared to the second quarter of 2025, driving a 54% increase in Peyto's realized condensate and pentanes plus price over the same period. Other NGLs increased 18% to \$28.48/bbl, compared to \$24.21/bbl due to higher realized butane prices. The increase in the realized NGL price was partly offset by a higher realized NGL hedging loss of \$12.42/bbl in the quarter. Peyto's realized NGL price, after hedging, rose to \$64.98/bbl, compared to \$58.43/bbl for the second quarter of 2025.

For the six months ended June 30, 2026, Peyto's NGL price, after hedging, increased 5% to \$63.95/bbl from \$60.68/bbl in the same period of 2025, primarily due to the increase in benchmark oil prices, partially offset from increased realized NGL hedging losses.

The Company's liquids were actively marketed with condensate being sold on a monthly index differential linked to WTI oil prices. Peyto's NGLs (a blend of pentanes plus, butane, and propane) are fractionated by a third party in Fort Saskatchewan, Alberta; however, Peyto markets each product separately. Pentanes plus were sold on a monthly index differential linked to WTI, with some volumes forward sold on fixed differentials to WTI. Butane was sold as a % of WTI or a fixed differential to the Mount Belvieu, Texas market. Propane was sold on a fixed differential to the Conway, Kansas market and the Mount Belvieu (LST), Texas market. While some products were sold pursuant to annual term contracts to ensure delivery paths remain open, others were marketed on the daily spot market.

Peyto has NGL marketing contracts whereby the Company purchases NGL mix from third parties, transports and fractionates the product, and sells the NGL components. The marketing revenue and marketing purchases are recorded gross on Peyto's income statement and are accounted for separately from Peyto's own production.

For the second quarter of 2026, Peyto recorded marketing revenue totaling \$6.8 million, and marketing purchases of \$6.3 million, compared to marketing revenue of \$5.4 million, and marketing purchases of \$4.8 million for the second quarter of 2025. Year to date, marketing revenue totaled \$11.6 million, and marketing purchases totaled \$10.4 million, compared to \$13.7 million and \$12.1 million, respectively, for the same period of 2025. The decrease in marketing revenue and marketing purchases for the three and six months ended June 30, 2026, was due to decreased contracted third-party volumes.

Peyto's other income includes third-party gathering and processing income, sales of excess natural gas transportation service, and electricity sales generated by the Company's cogeneration facility at the Edson Gas Plant. For the second quarter of 2026, other income increased 20% to \$5.8 million compared to \$4.8 million for the second quarter of 2025. Year to date, other income increased to \$14.6 million from \$7.3 million for the same period of 2025. The increases in the three and six months ended June 30, 2026, compared to the same periods of 2025, were mainly due to increased sales of excess transportation service.

## Royalties

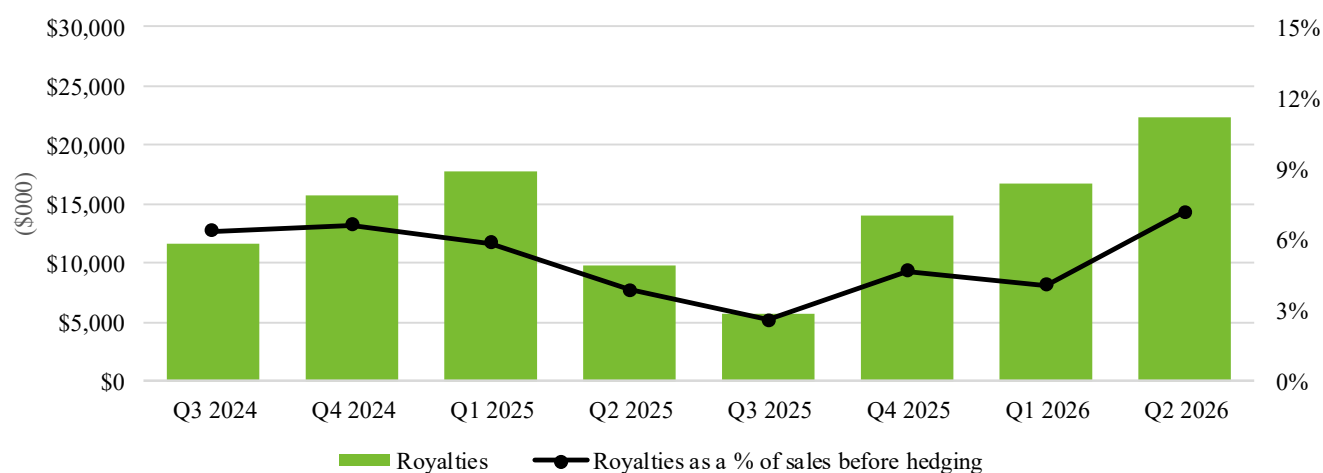
Royalties are paid to the owners of the mineral rights with whom leases are held, including the provincial government of Alberta. Alberta Crown royalties on natural gas and NGLs are invoiced on the Crown's share of production based on a monthly established reference price ("Reference Price"). The natural gas Reference Price is a monthly weighted average price of gas consumed in Alberta and gas exported from Alberta reduced for transportation and marketing allowances. Royalties also include Gas Cost Allowance ("GCA"), which reduces royalties payable to the Crown for capital and operating expenditures incurred by Peyto in gathering and processing the Crown's share of natural gas and NGL production. Additionally, all of Peyto's new wells qualify for the Alberta Crown Drilling and Completion Cost Allowance program, which has a 5% initial royalty rate under the Modernized Royalty Framework.

For the three and six months ended June 30, 2026, royalties increased to \$22.3 million and \$39.0 million, respectively, from \$9.8 million and \$27.5 million in the same periods of 2025. On a percentage of sales basis, royalties rose to 7.2% and 5.4% for the three and six months ended June 30, 2026, respectively, from 3.8% and 4.9% for the comparative prior periods. The increased royalties in the three and six months ended June 30, 2026, were driven by higher NGL royalties, from increased NGL sales relative to total sales, coupled with decreased GCA credits associated with Peyto's 2026 gathering and processing facility additions.

In its 27-year history, Peyto has invested over \$9.5 billion in capital projects and acquisitions, found, acquired and developed 7.2 TCF of natural gas reserves and paid over \$1.3 billion in royalties.

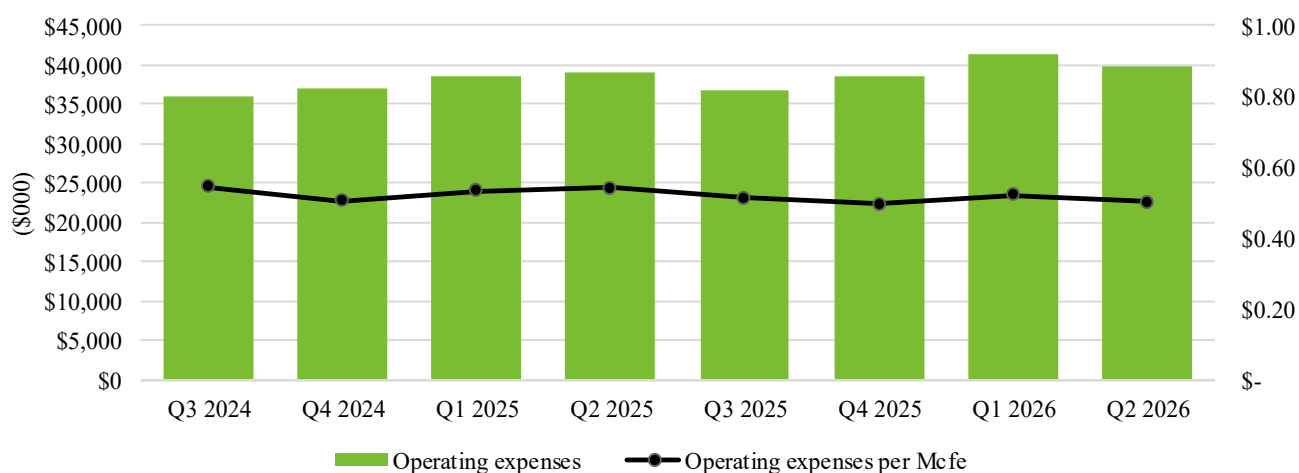

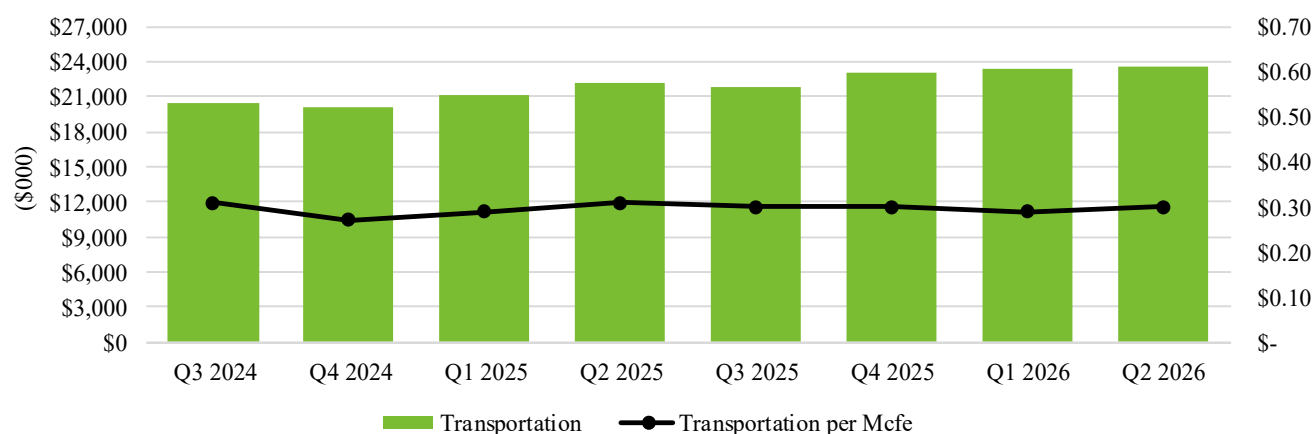
For the three and six months ended June 30, 2026, operating costs rose to \$39.8 million and \$81.3 million, respectively, compared to \$38.9 million and \$77.5 million for the same periods of 2025, driven by increased production volumes. On a unit-of-production basis, operating costs decreased 7% to \$0.50/Mcfe in the second quarter of 2026 from \$0.54/Mcfe in the same period of 2025. In the six months ended June 30, 2026, operating costs decreased 6 per cent to \$0.51/Mcfe compared to \$0.54/Mcfe in the same period of 2025. The decreases on a unit-of-production basis are primarily due to cost efficiencies from incremental production volumes.

Transportation expenses rose to \$23.6 million and \$47.0 million for the three and six months ended June 30, 2026, respectively, from \$22.2 million and \$43.3 million for the same periods of 2025, driven by toll increases and new Dawn service that commenced in the fourth quarter of 2025. On a unit-of-production basis, transportation expenses were \$0.30/Mcfe and \$0.30/Mcfe for the three and six months ended June 30, 2026, respectively, compared to \$0.31/Mcfe and \$0.30/Mcfe the same periods of 2025.

### Transportation



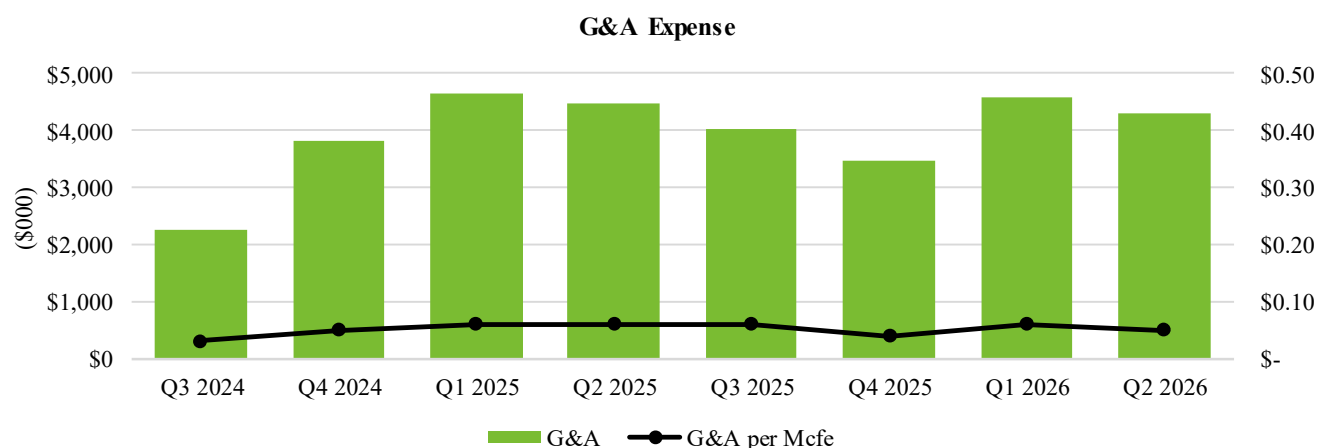

For the second quarter of 2026, G&A expenses (before overhead recoveries) were \$7.5 million, consistent with \$7.5 million for the second quarter of 2025. For the first half of 2026, gross G&A expenses increased to \$15.9 million from \$15.4 million in the first half of 2025, primarily due to increased employment and information technology, partially offset by lower rent expense.

Gross G&A expenses averaged \$0.09/Mcfe before overhead recoveries of \$0.04/Mcfe for G&A expenses of \$0.05/Mcfe in the second quarter of 2026 (\$0.10/Mcfe before overhead recoveries of \$0.04/Mcfe for G&A expenses of \$0.06/Mcfe in the second quarter of 2025).

Peyto capitalizes G&A expenses and performance-based compensation related to the execution of its capital program. For the three and six months ended June 30, 2026, Peyto capitalized \$2.3 million and \$5.8 million, respectively, of expenses directly attributable to exploration and development activities compared to \$2.9 million and \$5.4 million for the same periods of 2025.



### Performance and Stock-Based Compensation

The Company awards performance-based compensation to employees, key consultants and directors. Performance and stock-based compensation is comprised of stock options, deferred share units, and reserve value-based bonus.

#### Performance-Based Compensation

The reserve value-based component is 4% of the incremental increase in after-tax per share value, if any, as adjusted to reflect changes in debt, dividends, general and administrative expenses and interest expense, of proved producing reserves calculated using un-escalated, unhedged average realized prices of the current year and a discount rate of 8%. Peyto accrued \$3.0 million and \$6.0 million for performance-based compensation expense in the three and six months ended June 30, 2026 (2025 - \$2.5 million and \$5 million).

#### Stock-Based Compensation

##### Total Shareholder Return Rights

In May 2025, the Company adopted, and shareholders approved the Total Shareholder Return Rights Plan ("TSRRP") to replace Peyto's stock option program as the Company's only security-based compensation arrangement for employees, executive officers and consultants. Under the TSRRP, participants are granted rights ("Rights") that vest ratably over three years. The future value of which is based on the difference between the market value of the common shares on the date of grant and the market value of the common shares on vesting date, plus the dividends paid to shareholders during such period. Plan participants who are executive officers of the Company will be subject to performance conditioning metrics on 50% of the Rights granted to them (the "Performance Rights").

Employees and officers are expected to settle any in-the-money rights through the issuance of common shares, which will be issued from treasury. Rights held by consultants are expected to be settled in cash. The TSRRP provides that the aggregate number of common shares issuable thereunder and under all other security-based compensation arrangements of the Company at any time may not exceed 6.5% of the total number of issued and outstanding common shares from time to time.

##### Stock Options

The Company has a stock option plan allowing for the granting of stock options to officers, employees and consultants of the Company. Stock options were granted periodically with a three-year vesting period. At the vesting, recipients have thirty days to exercise options after which any unexercised options expire. With the adoption and approval of the TSRRP, Peyto has ceased granting new awards under the stock option plan. Outstanding stock options will vest, exercise or expire according to original grant agreements, with the final tranche vesting in January 2028.

### Deferred Share Units

Peyto has a deferred share unit ("DSU") plan, whereby DSUs may be issued to members of the Board of Directors. Each DSU is a notional unit equal in value to one Common Share, which entitles the holder to receive a common share upon redemption. DSUs vest immediately but can only be converted to a share upon the holder ceasing to be a Director of the Company. The expense associated with the DSU plan is determined based on the 5-day VWAP of Common Shares at the grant date. The expense is recognized in the income statement in the quarter in which the units are granted, with a corresponding charge to contributed surplus in the balance sheet.

### Stock-Based Compensation Expense

Stock-based compensation is calculated on 5.4 million non-vested stock options (2.6% of the total number of common shares outstanding), 5.7 million Rights (2.8% of the total number of common shares outstanding) and 0.4 million vested DSUs (0.2% of the total number of common shares outstanding). Peyto records a non-cash provision for compensation expense over the life of the awards calculated using Black-Scholes and Monte Carlo simulation valuation models. Stock-based compensation expense for the three and six months ended June 30, 2026, was \$4.4 million and \$7.9 million, respectively (2025 - \$3.7 million and \$7.2 million).

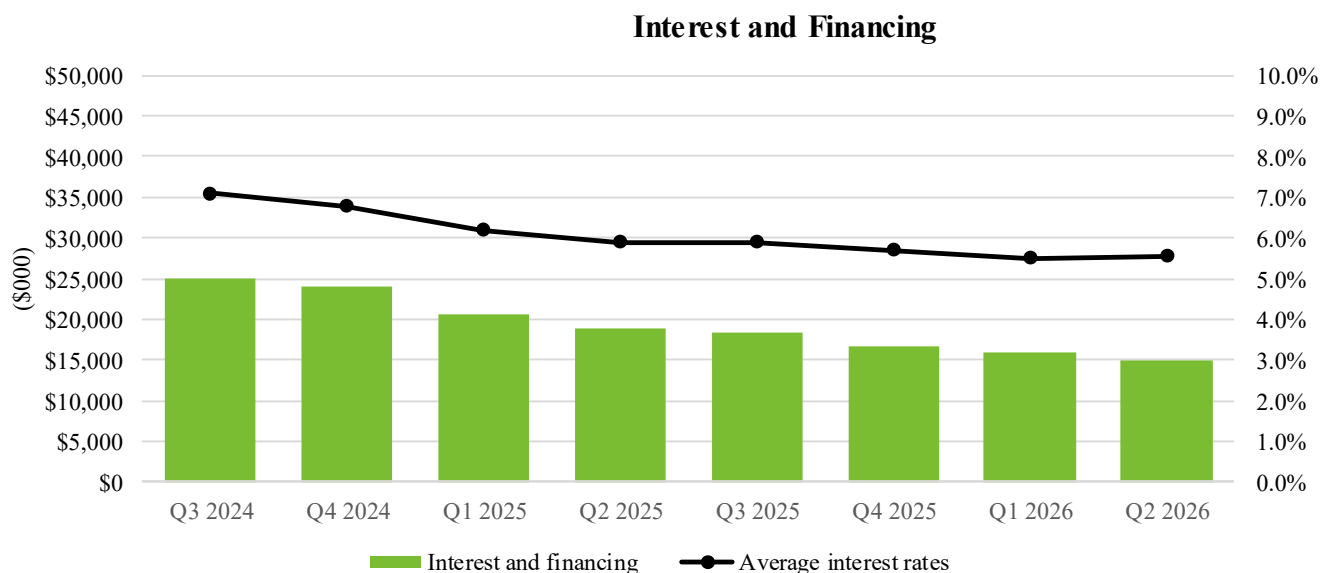

For the three and six months ended June 30, 2026, interest and financing costs fell to \$14.8 million and \$30.7 million, respectively, compared to \$18.9 million and \$39.5 million for the same periods of 2025. The decrease in interest and financing costs is due to a lower average bank debt outstanding combined with lower interest rates on the Company's bank debt, compared to the same periods of 2025. Year to date, Peyto's average interest rate fell to 5.5% from 6.1% for the same period of 2025, primarily driven by decreases to the Bank of Canada's policy rate.

Accretion expense was \$3.0 million and \$6.1 million for the three and six months ended June 30, 2026, respectively, compared to \$3.3 million and \$6.4 million for the same periods of 2025.

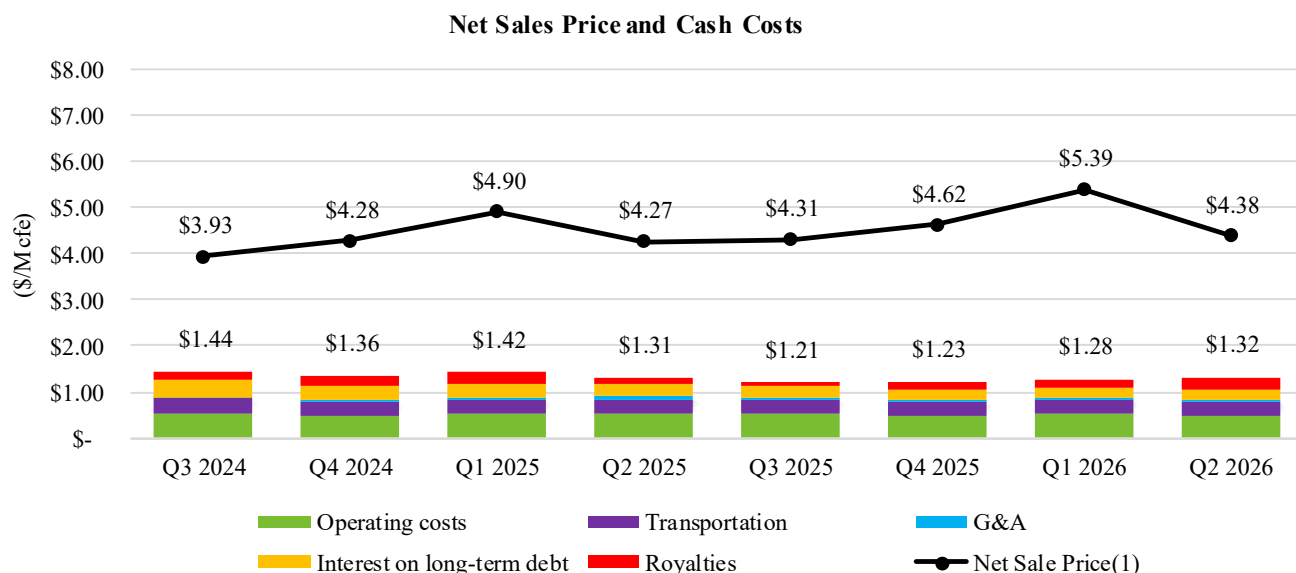

The primary factors that produce Peyto's strong netbacks and high margins are a low-cost structure and its hedging and diversification program.

The Company's depletion and depreciation totaled \$101.8 million (\$1.28/Mcf) in the second quarter of 2026 compared to \$95.8 million (\$1.33/Mcf) in the second quarter of 2025. In the first half of 2026, depletion and depreciation totaled \$204.0 million (\$1.28/Mcf) compared to \$192.5 million (\$1.33/Mcf) for the same period of 2025. The increases on an absolute basis are due to higher production volumes over the same periods in 2025. The decreases in depletion and depreciation on a per-unit basis reflect a lower depletion rate due to updated reserves and future development costs.

## Income Taxes

Peyto recorded current tax expense of \$22.8 million in the second quarter of 2026, down from \$26.0 million in the same quarter of 2025. This decrease was due to the recognition of a prior-year recovery resulting from legislative changes made in Bill C-15 that reinstated accelerated investment and resource deductions. For the first half of 2026, the Company recorded current tax of \$66.0 million, up from \$55.8 million for the same period of 2025 due to higher taxable income compared to the corresponding period in 2025.

For the three and six months ended June 30, 2026, deferred tax expense was \$10.4 million and \$19.5 million, respectively, compared to \$1.0 million and \$6.3 million for the same periods of 2025.

## MARKETING AND RISK MANAGEMENT

### Financial Derivative Instruments

The Company is a party to certain derivative financial instruments, including fixed price contracts. The Company enters into these forward contracts with well-established counterparties for the purpose of protecting a portion of its future revenues from the volatility of oil, natural gas prices, the foreign exchange rate and interest rates. To minimize counterparty risk, these marketing contracts are executed with financial institutions which are members of Peyto's banking syndicate.

Financial derivative instruments are valued on the consolidated balance sheet using quoted market prices at period end. Physical delivery contracts are not considered financial instruments and therefore, no asset or liability is recognized on the consolidated balance sheet.

### Commodity Price Risk Management

During the three and six months ended June 30, 2026, Peyto recorded realized hedging gains on commodity contracts of \$37.5 million and \$57.9 million, respectively, compared to \$54.6 million and \$110.2 million for the same periods of 2025. #### Unrealized Gain on Derivative Financial Instruments

For the three and six months ended June 30, 2026, the Company recognized an unrealized gain on derivative financial instruments of \$2.4 million and \$2.4 million, respectively (2025: nil and nil) related to covered call option contracts and an embedded derivative. The call option contracts are tabled above, and the embedded derivative is detailed below.

#### Embedded Derivative

Peyto has a long-term agreement to deliver 50,000 MMBtu/d of natural gas for a term of 10 years, which delivery is expected to commence in 2029. Under the terms of the agreement, the Company will deliver natural gas at Alberta's Nova Inventory Transfer point and receive a Dutch TTF index price less associated deductions. Peyto has identified an embedded derivative within this contract as a result of the pricing structure, and the host contract is a natural gas sales agreement with an underlying AECO price. The Company recognizes gains (losses) on risk management contracts related to the embedded derivative. For the three and six month period ended June 30, 2026, the Company recognized an unrealized gain on the embedded derivative of \$6.5 million and \$6.5 million, respectively (2025: nil and nil). At June 30, 2026, the fair value of the embedded derivative was \$6.5 million (December 31, 2025, nil). See note 11 in the Company's Q2 2026 financial statements for further details.

### Interest Rate Contracts

During the three and six months ended June 30, 2026, Peyto recorded realized hedging losses on interest rate swaps of \$49 thousand and \$221 thousand, respectively, compared to \$53 thousand and \$37 thousand for the same periods of 2025. Realized losses on interest rate swaps are recorded to interest expense. Peyto has the following interest rate swap contracts in place at June 30, 2026.

### Commodity Price Sensitivity

Peyto's earnings are largely determined by commodity prices for crude oil and natural gas including the US/Canadian dollar exchange rate. Volatility in these oil and gas prices can cause fluctuations in Peyto's earnings and cash flow. Low operating costs and a long reserve life reduce Peyto's sensitivity to changes in commodity prices.

### Currency Risk Management

The Company is exposed to fluctuations in the Canadian/US dollar exchange ratio since commodities are effectively priced in US dollars and converted to Canadian dollars. Peyto mitigates exchange rate risks using foreign exchange forward contracts and by hedging certain products with Canadian dollar contracts. Additionally, the \$40 million USD in senior secured notes provides structural foreign exchange risk mitigation.

### Interest Rate Risk Management

The Company is exposed to interest rate risk in relation to interest expense on its revolving credit facility and term loan. Peyto uses interest rate swaps on a portion of its floating rate debt to mitigate its interest rate exposure. At June 30, 2026, the increase or decrease in earnings for each 100 bps (1%) change in weighted average borrowing rate paid on the outstanding revolving credit facility amounts to approximately \$1.4 million per quarter. The average debt outstanding for the quarter was \$1.07 billion (including \$491 million fixed rate debt).

### Cash Flow from Operating Activities and Funds from Operations

For the second quarter of 2026, cash flow from operating activities increased to \$223.4 million from \$174.4 million in the second quarter of 2025. Funds from operations ("FFO") increased 19% to \$227.7 million for the second quarter of 2026, compared to \$191.3 million in the second quarter of 2025. These increases were primarily driven by:

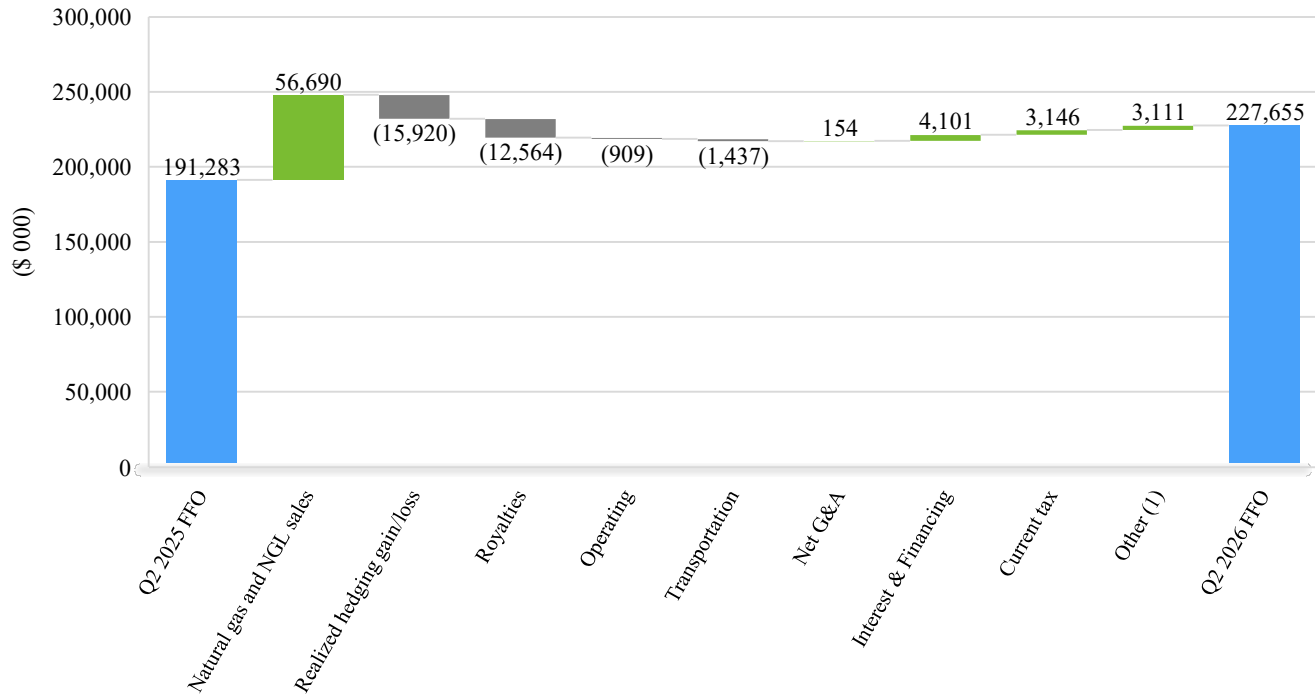
- higher production volumes, realized NGL prices, other income, and a realized gain on foreign exchange, combined with lower interest and financing costs and current tax expense;
- partially offset by lower realized hedging gains, and higher royalties, operating, and transportation expenses.

For the six months ended June 30, 2026, cash flow from operating activities increased to \$496.7 million from \$393.7 million for the same period of 2025. FFO totaled \$520.7 million in the first half of 2026, compared to \$416.6 million for the same period of 2025. These increases were mainly due to:

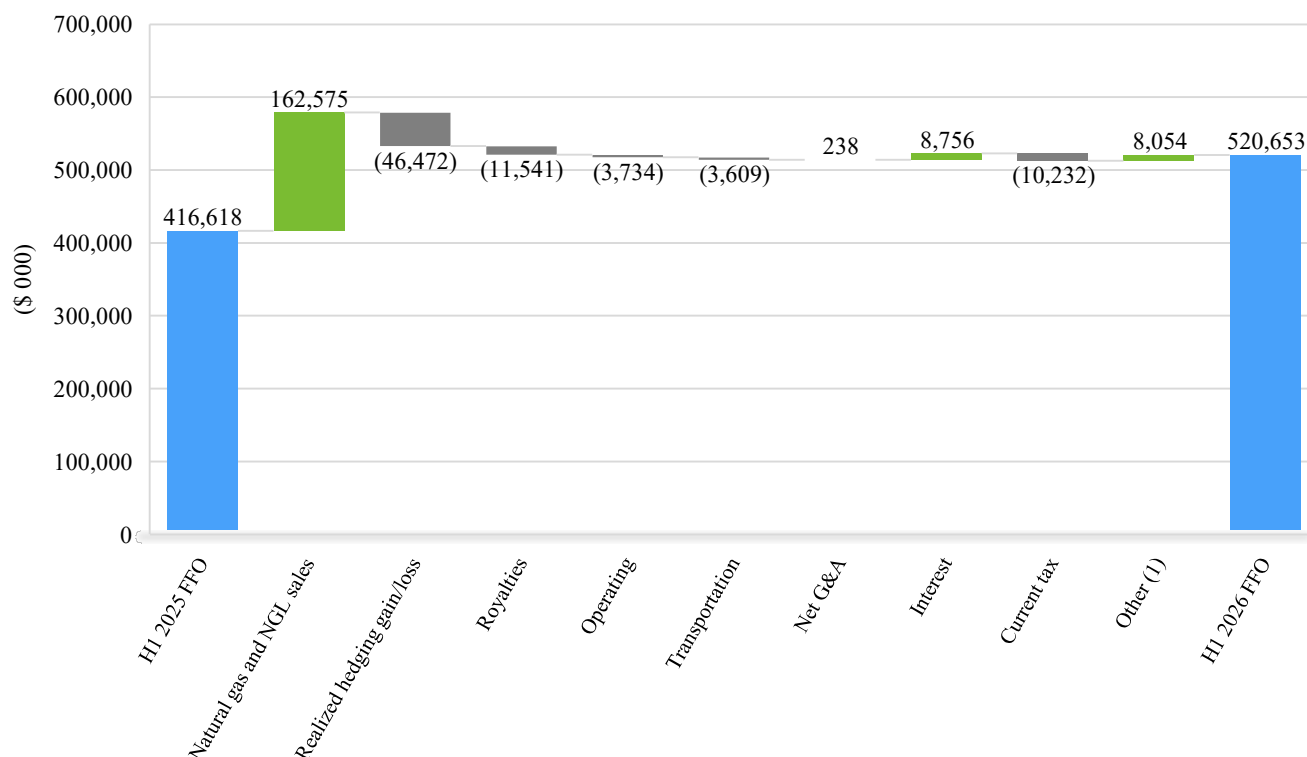
- higher production volumes, realized natural gas and NGL prices, other income, and a realized gain on foreign exchange, combined with lower interest and financing costs;
- partially offset by lower realized hedging gains, and higher royalties, operating, transportation, and current tax expenses.

### Free Funds Flow

Peyto uses free funds flow, defined as cash flow from operating activities before changes in non-cash operating working capital, provision for performance-based compensation, and transaction costs, less total capital expenditures, as an indicator of the funds available for capital allocation. For the three and six months ended June 30, 2026, free funds flow was \$140.6 million and \$280.3 million, respectively, compared to \$83.7 million and \$204.0 million for the same periods of 2025. Free funds flow is a non-GAAP financial measure, refer to the section entitled "Non-GAAP and Other Financial Measures" for additional information contained within this MD&A.

### Earnings

The Company's earnings in the three and six months ended June 30, 2026, rose to \$106.3 million and \$277.3 million, respectively, from \$87.8 million and \$201.9 million for the same periods of 2025. These increases were primarily driven by:

- higher sales revenue, increased realized gains on foreign exchange, an unrealized gain on derivative financial instruments, along with lower financing costs;
- partially offset by lower realized hedging gains, increased unrealized losses on foreign exchange, and higher royalties, operating, transportation, performance-based compensation, depletion and depreciation, and income taxes.

### Adjusted Earnings

Peyto uses adjusted earnings for its own performance measure and to provide investors with a measurement of the Company's earnings prior to the non-cash effects of unrealized gains and losses on financial instruments and unrealized gains and losses on foreign exchange. The Company's adjusted earnings in the three and six months ended June 30, 2026, rose to \$105.0 million and \$277.0 million, respectively, from \$84.9 million and \$199.0 million for the same periods of 2025. These increases were primarily driven by:

- higher sales revenue, increased realized gains on foreign exchange and lower financing costs;
- partially offset by lower realized hedging gains, and higher royalties, operating, transportation, performance-based compensation, depletion and depreciation, and income taxes.

## Capital Expenditures

Peyto invested \$84.9 million in capital expenditures for the second quarter of 2026. The Company drilled 10 wells (10.0 net), completed 14 wells (14.0 net) and brought 15 wells (15.0 net) on production for drilling, completions, equipping and tie-in capital of \$67.8 million. Facilities and pipeline projects totaled \$13.6 million in the quarter, which included production optimization projects, turnarounds at the Kakwa, Cecilia and Brazeau gas plants, along with pipeline de-bottlenecking in the Nosehill, Edson and Swanson areas of Sundance. Additionally, Peyto invested \$1.8 million in Crown land sales in the quarter.

Peyto's net debt of \$1.02 billion as at June 30, 2026, decreased by \$161.7 million from December 31, 2025.

The Company's 2026 capital expenditure budget is \$450 to \$500 million. Peyto believes funds from operations based on current strip pricing, together with available borrowings under the Revolving Facility will be sufficient to maintain dividends, finance current operations, and fund the planned capital expenditure program.

The total amount of capital invested in 2026 will be driven by the number and quality of projects generated. Capital will only be invested if it meets the long-term return objectives of the Company. The majority of the capital program will involve drilling,

completion and tie-in of lower risk development gas wells. Peyto's rapidly scalable business model has the flexibility to match planned capital expenditures to actual cash flow.

On October 23, 2025, the Company entered into an agreement with its syndicate of lenders to amend and extend its credit facilities, which increased the revolving operating facility (the "Revolving Credit Facility") to \$1.05 billion. The maturity date of the Revolving Credit Facility was extended to October 23, 2029, and consisted of a \$40 million working capital tranche and a \$1.01 billion production line, available on a revolving basis. Effective June 12, 2026, the Company reallocated the commitments under the Revolving Credit Facility, with no change to the total committed amount of \$1.05 billion or the maturity date. Following this amendment, the Revolving Credit Facility consists of a \$155 million working capital tranche and an \$895 million production line.

Borrowings under the Revolving Credit Facility bears interest at Canadian bank prime or US base rate, or, at Peyto's option, Canadian dollar CORRA advances or US dollar SOFR loan rates, plus adjustments and applicable margin.

The Company had \$136.4 million letters of credit outstanding at June 30, 2026 (\$9.1 million at December 31, 2025).

Peyto is subject to financial covenants as defined in the credit facility and note purchase agreements. The Company's financial covenants include financial measures defined within its revolving credit facility agreement that are not defined under the Accounting Standards. These financial measures are defined in the amended credit facility agreement as follows:

- Total Debt: includes long-term debt and subordinated debt plus bank overdraft and letters of credit.
- Senior Debt: includes long-term debt plus bank overdraft and letters of credit.
- EBITDA: trailing twelve-month net income before non-cash items, interest, and income taxes.

## RISK FACTORS

Investors who purchase common shares are participating in the total returns from a portfolio of western Canadian natural gas producing properties. As such, the total returns earned by investors and the value of the shares are subject to numerous risks inherent in the oil and natural gas industry.

### Prices, Markets and Marketing

Expected returns depend largely on the volume of petroleum and natural gas production and the price received for such production, along with the associated costs. The price received for oil depends on a number of factors, including West Texas Intermediate oil prices, Canadian/US currency exchange rates, quality differentials and Edmonton par oil prices. The price received for natural gas production is dependent on current Alberta, Henry Hub, Malin, Dawn, Chicago, Ventura, and Emerson market prices and Canadian/US currency exchange rates. Peyto's marketing strategy is designed to smooth out short-term fluctuations in the price of natural gas through future sales. It is meant to be methodical and consistent and to avoid speculation.

Access to markets may be restricted at times by pipeline or processing capacity. These risks are minimized by controlling as much of the processing and transportation activities as possible and ensuring transportation and processing contracts are in place with reliable cost-efficient counterparties.

### Exploration, Development and Production Risks

Inherent in development of the existing oil and gas reserves are the risks, among others, of drilling dry holes, encountering production or drilling difficulties or experiencing high decline rates in producing wells. To minimize these risks, Peyto employs experienced staff to evaluate and operate wells and utilize appropriate technology in operations. In addition, prudent work practices and procedures, safety programs and risk management principles, including insurance coverage protect Peyto against certain potential losses.

Although Peyto's focus is on internally generated drilling programs, any acquisition of oil and natural gas assets depends on an assessment of value at the time of acquisition. Incorrect assessments of value can adversely affect dividends to shareholders and the value of the common shares. Peyto employs experienced staff and performs appropriate levels of due diligence on the analysis of acquisition targets, including a detailed examination of reserve reports; if appropriate, reengineering of reserves for a large portion of the properties to ensure the results are consistent; site examinations of facilities for environmental liabilities; detailed examination of balance sheet accounts; review of contracts; review of prior year tax returns and modeling of the acquisition to attempt to ensure accretive results to the shareholders.

### Cost, Supply Chain and Service Availability

Peyto's operating costs could escalate and become uncompetitive due to supply chain disruptions, inflationary cost pressures, equipment limitations, escalating supply costs, commodity prices, and additional government intervention through stimulus spending or additional regulations. Peyto's inability to manage costs may impact project returns and future development decisions, which could have a material adverse effect on its financial performance and cash flows.

The cost or availability of oilfield services may adversely affect Peyto's ability to undertake exploration, development and construction projects. The crude oil and natural gas industry is cyclical in nature and is prone to shortages of supply of equipment and services including drilling rigs, geological and geophysical services, engineering and construction services, major equipment items for infrastructure projects, and construction materials generally. These materials and services may not be available when required at reasonable prices. A failure to secure the services and equipment necessary to Peyto's operations

for the expected price, on the expected timeline, or at all, may have an adverse effect on Peyto's financial performance and cash flows.

### **Credit Facility Arrangements**

Peyto is subject to financial market risk. Peyto routinely monitors its financial forecasts, capital spending, balance sheet and dividend policy and has the ability to make operational and financial changes to help ensure Peyto remains compliant with all financial covenants. If necessary, Peyto can request temporary relief from financial covenants from lenders.

In the event Peyto does not comply with its financial covenants and lenders do not grant covenant relief, Peyto's access to capital could be restricted or repayment required. In order to maintain substantial rates of growth, Peyto must continue reinvesting in, drilling for or acquiring petroleum and natural gas. The capital expenditure program is funded primarily through funds from operations, debt and, if appropriate, equity.

### **Reserves Estimates**

The value of Peyto's common shares is based on, among other things, the underlying value of the oil and natural gas reserves. Geological and operational risks can affect the quantity and quality of reserves and the cost of ultimately recovering those reserves. Lower oil and gas prices increase the risk of write-downs on oil and gas property investments. In order to mitigate this risk, proven and probable oil and gas reserves are evaluated each year by a firm of independent reservoir engineers. Both the reserves committee and the Board of Directors reviews and approves the reserve report.

### **Regulatory Landscape**

The petroleum and natural gas industry is subject to extensive controls, regulatory policies and income and resource taxes imposed by various levels of government. These regulations, controls and taxation policies are amended from time to time.

Peyto has no control over the level of government intervention or taxation in the petroleum and natural gas industry. Peyto operates in such a manner to ensure, to the best of its knowledge that it is in compliance with all applicable regulations and are able to respond to changes as they occur.

Amendments to the Competition Act that came into force in June 2024 expressly target greenwashing by imposing substantiation requirements for certain environmental claims and increasing exposure for misleading environmental representations. The new requirements are complex and uncertain, and in some cases led companies to pause, withdraw, or revise voluntary environmental disclosures. Expanded private access to the Competition Tribunal for deceptive marketing matters came into force in June 2025, although subsequent amendments in Budget Implementation Act, 2025, No. 1 narrowed access for private proceedings and adjusted the substantiation framework for claims about the environmental benefits of a business or business activity. Despite these improvements, the regulatory landscape continues to evolve and penalties for corporations can reach \$10 million for a first order, \$15 million for subsequent orders, and may be higher depending on the benefit from the conduct, including in some cases up to 3% of annual worldwide gross revenues.

Companies making voluntary environmental disclosures face ongoing risk of liability and reputational harm. Uncertainty surrounding the interpretation and enforcement of this legislation may expose the Company to increased litigation and financial penalties, the outcome and impacts of which can be difficult to assess or quantify and may have a material adverse effect on the Company's business, reputation, financial condition, and results.

### **Changing Investor Sentiment**

The petroleum and natural gas industry is subject to both environmental regulations and an increased environmental awareness. Peyto has reviewed its environmental risks and is, to the best of its knowledge, in compliance with the appropriate environmental legislation and have determined that there is no current material impact on operations. Peyto employs environmentally responsible business operations and looks to both Alberta provincial authorities and Canada's federal authorities for direction and regulation regarding environmental and climate change legislation.

A number of factors, including the effects of the use of hydrocarbons on climate change, the impact of crude oil and natural gas operations on the environment, environmental damage relating to spills of crude oil products during production and transportation, and Indigenous rights, have affected certain investors' sentiments towards investing in the crude oil and natural gas industry. As a result of these concerns, some institutional, retail and governmental investors have announced that they are no longer funding or investing in crude oil and natural gas assets or companies or are reducing the amount thereof over time. In addition, certain institutional investors are requesting that issuers develop and implement more robust ESG policies and practices. Developing and implementing such policies and practices can involve significant costs and require a significant time commitment from the Board, Management and employees of Peyto.

Failing to implement the policies and practices, as requested by institutional investors, may result in such investors reducing their investment in Peyto, or not investing in Peyto at all. Any reduction in the investor base interested or willing to invest in the crude oil and natural gas industry and more specifically, Peyto, may result in limiting Peyto's access to capital, increasing the cost of capital, and decreasing the price and liquidity of Peyto's securities even if Peyto's operating results, underlying asset values, or cash flows have not changed.

### **Alternatives to and Changing Demand for Petroleum Products**

Changes to the demand for oil and natural gas products and the rise of petroleum alternatives may negatively affect Peyto's financial condition, results of operations and cash flows. Fuel conservation measures, alternative fuel requirements, increasing consumer demand for alternatives to oil and natural gas and technological advances in fuel economy and renewable energy generation systems could reduce the demand for oil, natural gas and liquid hydrocarbons. Recently, certain jurisdictions have implemented policies or incentives to decrease the use of hydrocarbons and encourage the use of renewable fuel alternatives, which may lessen the demand for petroleum products and put downward pressure on commodity prices. Advancements in energy efficient products have a similar effect on the demand for oil and natural gas products.

Peyto cannot predict the impact of changing demand for oil and natural gas products, and any major changes may have a material adverse effect on Peyto's business, financial condition, results of operations and cash flow by decreasing Peyto's profitability, increasing its costs, limiting its access to capital and decreasing the value of its assets.

### **Information Technology Systems and Cyber-Security**

Peyto has become increasingly dependent upon the availability, capacity, reliability, and security of our information technology infrastructure and our ability to expand and continually update this infrastructure to conduct daily operations. Peyto depends on various information technology systems to estimate reserve quantities, process and record financial data, manage Peyto's land base, manage financial resources, analyze seismic information, administer contracts with operators and lessees, and communicate with employees and third-party partners.

Cyber-security breaches, as well as the loss of or unauthorized access to electronic data may adversely impact Peyto's operations and financial position. Further, Peyto is subject to a variety of information technology and system risks as a part of its normal course operations, including potential breakdown, invasion, virus, cyber-attack, cyber-fraud, security breach, and destruction or interruption of Peyto's information technology systems by third parties or insiders. Unauthorized access to these systems by employees or third parties could lead to corruption or exposure of confidential, fiduciary or proprietary information, interruption to communications or operations or disruption to business activities, or Peyto's competitive position. Disruption of critical information technology services, or breaches of information security, could have a negative effect on Peyto's performance and earnings, as well as its reputation, and any damages sustained may not be adequately covered by Peyto's current insurance coverage, or at all.

Peyto provides employees with social media guidelines that align with its Code of Business Conduct and Ethics Policy. Despite these efforts, as social media continues to grow in influence and access to social media platforms becomes increasingly prevalent, there are significant risks that Peyto may not be able to properly regulate social media use and preserve adequate records of business activities.

In addition, cyber-phishing attempts, in which a malicious party attempts to obtain sensitive information such as usernames, passwords, credit card and banking details, or approval of wire transfer requests by disguising as a trustworthy entity in an electronic communication, have become more widespread and sophisticated in recent years.

Increasingly, social media is used as a vehicle to carry out cyber-phishing attacks. Information posted on social media sites, for business or personal purposes, may be used by attackers to penetrate Peyto's systems and obtain confidential information. Peyto's employees are often the targets of such cyber-phishing attacks, as they are and will continue to be targeted by parties using fraudulent "spoof" emails to misappropriate information or to introduce viruses or other malware through "Trojan horse" programs to Peyto's computers. These emails appear to be legitimate emails, but direct recipients to fake websites operated by the sender of the email or request recipients to send a password or other confidential information through email or to download malware. If Peyto becomes a victim to a cyber-phishing attack it could result in a loss or theft of Peyto's financial resources or critical data and information or could result in a loss of control of Peyto's technological infrastructure or financial resources. The significance of any such event is difficult to quantify but may in certain circumstances be material and could have a material adverse effect on Peyto's business, financial condition, and results of operations.

Despite these threats and the residual risk that remains, Peyto applies technical and process controls in line with industry-accepted standards to protect its information, assets and systems, including a written incident response plan for responding to a cybersecurity incident. However, these controls may not adequately prevent cyber-security breaches. Peyto maintains policies and procedures that address and implement employee protocols with respect to electronic communications and electronic

devices and conducts regular cyber-security risk assessments and training and education programs for its employees. Peyto also employs encryption protection of its confidential information on all computers and other electronic devices. Despite Peyto's efforts to mitigate such cyber-phishing attacks through education and training, cyber-phishing activities remain a serious problem that may damage its information technology infrastructure

### **Geopolitical Risks**

There is a risk that (i) the tariffs that are currently in effect on goods exported from or imported into Canada continue in effect for an extended period of time, the tariffs that have been threatened are implemented, that tariffs that are currently suspended are reactivated, the rate or scope of tariffs are increased, or new tariffs are imposed, including on oil and natural gas, (ii) the U.S. and/or Canada imposes any other form of tax, restriction or prohibition on the import or export of products from one country to the other, including on oil and natural gas, and (iii) the tariffs imposed or threatened to be imposed by the U.S. on other countries and retaliatory tariffs imposed or threatened to be imposed by other countries on the U.S., will trigger a broader global trade war which could have a material adverse effect on the Canadian, U.S. and global economies, and by extension the Canadian oil and natural gas industry and the Company, including by decreasing demand for (and the price of) oil and natural gas, disrupting supply chains, increasing costs, causing volatility in global financial markets, and limiting access to financing.

## **CONTROLS AND PROCEDURES**

### **Disclosure Controls and Procedures**

The Company's Chief Executive Officer and Chief Financial Officer have designed, or caused to be designed under their supervision, disclosure controls and procedures to provide reasonable assurance that: (i) material information relating to the Company is made known to the Company's Chief Executive Officer and Chief Financial Officer by others, particularly during the period in which the annual and interim filings are being prepared; and (ii) information required to be disclosed by the Company in its annual filings, interim filings or other reports filed or submitted by it under securities legislation is recorded, processed, summarized and reported within the time period specified in securities legislation.

### **Internal Control over Financial Reporting**

The Company's Chief Executive Officer and Chief Financial Officer have designed, or caused to be designed under their supervision, internal control over financial reporting to provide reasonable assurance regarding the reliability of the Company's financial reporting and the preparation of financial statements for external purposes in accordance with GAAP. Such officers have evaluated, or caused to be evaluated under their supervision, the effectiveness of the Company's internal control over financial reporting at the financial period end of the Company and concluded that the Company's internal control over financial reporting is effective, at the financial period end of the Company, for the foregoing purpose.

Peyto is required to disclose herein any change in Peyto's internal control over financial reporting that occurred during the period ended June 30, 2026, that has materially affected, or is reasonably likely to materially affect, Peyto's internal control over financial reporting. No material changes in Peyto's internal control over financial reporting were identified during such period that has materially affected, or are reasonably likely to materially affect, Peyto's internal control over financial reporting.

It should be noted that a control system, including the Company's disclosure and internal controls and procedures, no matter how well conceived, can provide only reasonable, but not absolute, assurance that the objectives of the control system will be met and it should not be expected that the disclosure and internal controls and procedures will prevent all errors or fraud.

## **OFF-BALANCE SHEET FINANCING**

Peyto does not have any guarantees or off-balance sheet arrangements that have been excluded from the balance sheets other than commitments disclosed in the "Contractual Obligations" section of this MD&A.

## **CRITICAL ACCOUNTING ESTIMATES**

### **Reserve Estimates**

Estimates of oil and natural gas reserves, by necessity, are projections based on geologic and engineering data, and there are uncertainties inherent to the interpretation of such data as well as the projection of future rates of production and the timing of

development expenditures. Reserve engineering is an analytical process of estimating underground accumulations of oil and natural gas that can be difficult to measure. The accuracy of any reserve estimate is a function of the quality of available data, engineering and geological interpretation and judgment. Estimates of economically recoverable oil and natural gas reserves and future net cash flows necessarily depend upon a number of variable factors and assumptions, such as historical production from the area compared with production from other producing areas, the assumed effects of regulations by governmental agencies and assumptions governing future oil and natural gas prices, future royalties and operating costs, development costs and workover and remedial costs, all of which may in fact vary considerably from actual results. For these reasons, estimates of the economically recoverable quantities of oil and natural gas attributable to any particular group of properties, classifications of such reserves based on risk recovery, and estimates of the future net cash flows expected there from may vary substantially. Any significant variance in the assumptions could materially affect the estimated quantity and value of the reserves, which could affect the carrying value of Peyto's oil and natural gas properties and the rate of depletion of the oil and natural gas properties as well as the calculation of the reserve value based compensation. Actual production, revenues and expenditures with respect to Peyto's reserves will likely vary from estimates, and such variances may be material.

Peyto's estimated quantities of proved and probable reserves at December 31, 2025 were evaluated by independent petroleum engineers GLJ Ltd.

### **Depletion and Depreciation Estimate**

All costs of exploring for and developing petroleum and natural gas reserves, together with the costs of production equipment, are capitalized and then depleted and depreciated on the unit-of-production method based on proved plus probable reserves. Petroleum and natural gas reserves and production are converted into equivalent units based upon estimated relative energy content (6 mcf to 1 barrel of oil). Costs for gas plants and other facilities are capitalized and depreciated on a declining balance basis.

### **Impairment of Long-Lived Assets**

Impairment is indicated if the carrying value of the long-lived asset or oil and gas cash generating unit exceeds its recoverable amount under the Accounting Standards. If impairment is indicated, the amount by which the carrying value exceeds the estimated fair value of the long-lived asset is charged to earnings. The determination of the recoverable amount for impairment purposes under the Accounting Standards involves the use of numerous assumptions and judgments including future net cash flows from oil and gas reserves, future third-party pricing, inflation factors, discount rates and other uncertainties. Future revisions to these assumptions impact the recoverable amount.

### **Decommissioning Provision**

The decommissioning provision is estimated based on existing laws, contracts or other policies. The fair value of the obligation is based on estimated future costs for abandonment and reclamation discounted at a risk-free interest rate. The liability is adjusted each reporting period to reflect the passage of time and for revisions to the estimated future cash flows, with the accretion charged to earnings. By their nature, these estimates are subject to measurement uncertainty and the impact on the financial statements could be material.

### **Reserve Value Performance Based Compensation**

The reserve value-based compensation is calculated using the year end independent reserves evaluation which was completed in February 2026. A quarterly provision for the reserve value-based compensation is calculated using estimated proved producing reserve additions adjusted for changes in debt, equity and dividends. Actual proved producing reserves additions and forecasted commodity prices could vary significantly from those estimated and may have a material effect on the calculation.

### **Income Taxes**

The determination of the Company's income and other tax liabilities requires interpretation of complex laws and regulations often involving multiple jurisdictions. All tax filings are subject to audit and potential reassessment after the lapse of considerable time. Accordingly, the actual income tax liability may differ significantly from that estimated and recorded.

### **Accounting Changes**

Voluntary changes in accounting policy are made only if they result in financial statements which provide more reliable and relevant information. Accounting policy changes are applied retrospectively unless it is impractical to determine the period or cumulative impact of the change. Corrections of prior period errors are applied retrospectively and changes in accounting estimates are applied prospectively by including these changes in earnings. When the Company has not applied a new primary source of GAAP that has been issued, but is not effective, the Company will disclose the fact along with information relevant to assessing the possible impact that application of the new primary source of GAAP will have on the financial statements in the period of initial application.

## NON-GAAP AND OTHER FINANCIAL MEASURES

Throughout this MD&A and in other materials disclosed by the Company, Peyto employs certain measures to analyze financial performance, financial position, and cash flow. These non-GAAP and other financial measures do not have any standardized meaning prescribed under IFRS and therefore may not be comparable to similar measures presented by other entities. The non-GAAP and other financial measures should not be considered to be more meaningful than GAAP measures which are determined in accordance with IFRS, such as net income (loss), cash flow from operating activities, and cash flow used in investing activities, as indicators of Peyto's performance.

### Non-GAAP Financial Measures

#### Funds from Operations

"Funds from operations" is a non-GAAP measure which represents cash flows from operating activities before changes in non-cash operating working capital, decommissioning expenditure, provision for performance-based compensation and transaction costs, if any. Management considers funds from operations and per share calculations of funds from operations to be key measures as they demonstrate the Company's ability to generate the cash necessary to pay dividends, repay debt and make capital investments. Management believes that by excluding the temporary impact of changes in non-cash operating working capital, funds from operations provides a useful measure of Peyto's ability to generate cash that is not subject to short-term movements in operating working capital. The most directly comparable GAAP measure is cash flows from operating activities.

#### Free Funds Flow

Peyto uses "free funds flow" as an indicator of the efficiency and liquidity of Peyto's business, measuring its funds after capital investment available to manage debt levels, pay dividends, and return capital to shareholders through activities such as share repurchases. Peyto calculates free funds flow as cash flows from operating activities before changes in non-cash operating working capital, provision for performance-based compensation, and transaction costs, less total capital expenditures, allowing Management to monitor its free funds flow to inform its capital allocation decisions. The most directly comparable GAAP measure to free funds flow is cash from operating activities. The following table details the calculation of free funds flow and the reconciliation from cash flow from operating activities to free funds flow.

## Non-GAAP Financial Ratios

### Funds from Operations per Share

Peyto presents funds from operations per share by dividing funds from operations by the Company's diluted or basic weighted average common shares outstanding. "Funds from operations" is a non-GAAP financial measure. Management believes that funds from operations per share provide investors an indicator of funds generated from the business that could be allocated to each shareholder's equity position.

### Adjusted earnings per Share

Peyto presents adjusted earnings per share by dividing adjusted earnings by the Company's diluted or basic weighted average common shares outstanding. "Adjusted earnings" is a non-GAAP financial measure. Management uses adjusted earnings as a performance measure and to provide investors with a measurement of the Company's earnings prior to the non-cash effects of unrealized gains and losses on financial instruments and unrealized gains and losses on foreign exchange.

### Netback per MCFE and BOE

"Netback" is a non-GAAP measure that represents the profit margin associated with the production and sale of petroleum and natural gas. Peyto computes "field netback per Mcfe" as commodity sales from production, plus net marketing revenue, if any, plus other income, less royalties, operating, and transportation expenses, divided by production. "Cash netback" is calculated as "field netback" less interest, less general and administration expense and plus or minus realized gain on foreign exchange, divided by production. "After-tax cash netback" is calculated as "cash netback" less current tax, divided by production. Netbacks are per-unit-of-production measures used to assess Peyto's performance and efficiency.

### Total Payout Ratio

## CONVERSION RATIO

Natural gas liquids volumes are recorded in barrels of oil (bbl) and are converted to a thousand cubic feet equivalent (Mcf) using a ratio of six (6) thousand cubic feet to one (1) barrel of oil (bbl). Natural gas volumes recorded in thousand cubic feet (mcf) are converted to barrels of oil equivalent (boe) using the ratio of six (6) thousand cubic feet to one (1) barrel of oil (bbl). Boe may be misleading, particularly if used in isolation. A boe conversion ratio of 6 Mcf:1 bbl is based in an energy equivalency conversion method primarily applicable at the burner tip and does not represent a value equivalency at the wellhead. In addition, given that the value ratio based on the current price of oil as compared with natural gas is significantly different from the energy equivalent of six to one, utilizing a boe conversion ratio of 6 Mcf:1 bbl may be misleading as an indication of value.

#### **1. Nature of operations**

Peyto Exploration & Development Corp and its subsidiaries (together “Peyto” or the “Company”) is a Calgary based oil and natural gas company. Peyto conducts exploration, development, and production activities in Canada. Peyto is incorporated and domiciled in the Province of Alberta, Canada. The address of its head office is 300, 600 – 3<sup>rd</sup> Avenue SW, Calgary, Alberta, Canada, T2P 0G5.

These condensed consolidated financial statements were approved and authorized for issuance by the Audit Committee of Peyto on August 11, 2026.

#### **2. Basis of presentation**

The condensed consolidated financial statements have been prepared by management and reported in Canadian dollars in accordance with IFRS® Accounting Standards (the “Accounting Standards”) as issued by the International Accounting Standards Board (“IASB”) applicable to the preparations of interim financial statements, including International Accounting Standard (“IAS”) 34, Interim Financial Reporting. These condensed consolidated financial statements do not include all of the information required for full annual consolidated financial statements and should be read in conjunction with the Company’s consolidated financial statements as at and for the year ended December 31, 2025.

#### **Material Accounting Policies**

##### **(a) Material Accounting Judgments Estimates and Assumptions**

The timely preparation of the condensed consolidated financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingencies, if any, as at the date of the consolidated financial statements and the reported amounts of revenue and expenses during the period. By their nature, estimates are subject to measurement uncertainty and changes in such estimates in future years could require a material change in the condensed consolidated financial statements.

All accounting policies and methods of computation followed in the preparation of these condensed consolidated financial statements are the same as those disclosed in Note 2 of Peyto’s consolidated financial statements as at and for the years ended December 31, 2025, except as noted below.

##### **(b) Changes in accounting policies**

On January 1, 2026, Peyto adopted amendments to IFRS 9, Financial Instruments, and IFRS 7, Financial Instruments: Disclosures to address the classification and measurement of financial instruments, with an emphasis to clarify the date of recognition and derecognition of financial asset and liabilities. This amendment does not have a material impact on the consolidated financial statements.

#### **Future Accounting Pronouncements**

##### **IFRS 18 Presentation and Disclosure in Financial Statements**

In April 2024, the IASB issued IFRS 18 Presentation and Disclosure in Financial Statements (“IFRS 18”), which will replace IAS 1 and includes requirements for all entities applying IFRS Accounting Standards for the presentation and disclosure of information in the financial statements. IFRS 18 will introduce new totals, subtotals, and categories for income and expenses in the statement of income, as well as requiring disclosure about management-defined performance

measures and additional requirements regarding the aggregation and disaggregation of certain information. It will be effective on January 1, 2027, with earlier adoption permitted, and it must be adopted on a retrospective basis.

The Company is currently assessing the impact of IFRS 18 on the presentation and disclosure of its consolidated financial statements. Upon adoption, management expects interest income, which is currently presented within finance costs in the consolidated statement of net income, to be presented within investing activities. In addition, interest income received and interest expense paid are expected to be classified as investing and financing cash flows, respectively, in the consolidated statement of cash flows, rather than as operating cash flows. The adoption of IFRS 18 is not expected to have any impact on the Company's financial position, net earnings, or total cash flows. The Company will continue to assess the presentation and disclosure implications of IFRS 18, including the identification of management-defined performance measures and the implementation of the related presentation and disclosure requirements.

On October 23, 2025, the Company entered into an agreement with its syndicate of lenders to amend and extend its credit facilities, which increased the revolving operating facility (the "Revolving Credit Facility") to \$1.05 billion. The maturity date of the Revolving Credit Facility was extended to October 23, 2029, and consists of a \$40 million working capital tranche and a \$1.010 billion production line, available on a revolving basis. Effective June 12, 2026, the Company reallocated the commitments under the Revolving Credit Facility, with no change to the total committed

amount of \$1.05 billion or the maturity date. Following this amendment, the Revolving Credit Facility consists of a \$155 million working capital tranche and an \$895 million production line.

Borrowings under the Revolving Credit Facility bears interest at Canadian bank prime or US base rate, or, at Peyto's option, Canadian dollar CORRA advances or US dollar SOFR loan rates, plus adjustments and applicable margin.

The Company had \$136.4 million of Letters of Credit outstanding at June 30, 2026 (\$9.1 million at December 31, 2025).

On January 5, 2026, Peyto issued \$100 million of senior secured notes. The notes have a coupon rate of 5.03% and mature on January 5, 2033. The notes were issued by way of a private placement pursuant to a note purchase agreement and rank equally with Peyto's obligations under its bank facility and existing note purchase and private shelf agreement. Interest will be paid semi-annually in arrears. Proceeds from the notes were used to repay the \$100 million, 4.39% notes that matured on January 3, 2026.

Peyto is subject to the following financial covenants as defined in the credit facility and note purchase agreements:

- Long-term debt and subordinated debt plus bank overdraft and letters of credit not to exceed 4.0 times trailing twelve-month net income before non-cash items, interest and income taxes;
- Long-term debt plus bank overdraft and letters of credit not to exceed 3.5 times trailing twelve-month net income before non-cash items, interest and income taxes.
- Trailing twelve months net income before non-cash items, interest and income taxes to exceed 3.0 times trailing twelve months interest expense.

Peyto is in compliance with all financial covenants at June 30, 2026.

Total interest expense for the three and six months ended June 30, 2026, was \$14.8 million and \$30.7 million (2025 - \$18.9 million and \$39.5 million) and the average borrowing rate for the period was 5.5% and 5.5% (2025 - 5.9% and 6.1%).

The Company has estimated the net present value of its total decommissioning provision to be \$329.6 million as June 30, 2026 (2025 - \$312.5 million) based on a total escalated future undiscounted liability of \$1,049.4 million (2025 - \$1,046.1

million). At June 30, 2026, management estimates that these payments are expected to be made over the next 50 years (2025 – 50 years) with the majority of payments being made in years 2042 to 2076. ### Dividends

### Comprehensive income

Comprehensive income consists of earnings and other comprehensive income ("OCI"). OCI comprises the change in the fair value of the effective portion of the derivatives used as hedging items in a cash flow hedge. "Accumulated other comprehensive income" is an equity category comprised of the cumulative amounts of OCI.

### Accumulated hedging gains and losses

Gains and losses from financial derivative instruments are accumulated until settled. These outstanding hedging contracts are recognized in earnings on settlement. Further information on these contracts is set out in Note 11.

## 8. Performance-based compensation

### Reserve based component

The reserves value-based component is 4% of the incremental increase in per share value, if any, as adjusted to reflect changes in debt, dividends, general and administrative expenses and interest expense, of proved producing reserves, calculated using un-escalated average realized prices of the current year and a discount rate of 8%. For three and six months ended June 30, 2026, Peyto accrued \$3.0 million and \$6.0 million for performance-based compensation, respectively (2025 - \$2.5 million and \$5.0 million).

## 9. Stock-based compensation

### Total Shareholder Return Rights

In May 2025, the Company adopted, and shareholders approved the Total Shareholder Return Rights Plan ("TSRRP") to replace Peyto's stock option program as the Company's only security-based compensation arrangement for employees, executive officers and consultants. Under the TSRRP, participants are granted rights ("Rights") that vest ratably over three years. The future value of which is based on the difference between the market value of the common shares on the date of grant and the market value of the common shares on vesting date, plus the dividends paid to shareholders during such period. Plan participants who are executive officers of the Company will be subject to performance conditioning metrics on 50% of the Rights granted to them (the "Performance Rights"). Employees and officers are expected to settle any in-the-money rights through the issuance of common shares, which will be issued from treasury. Rights held by consultants are expected to be settled in cash. The TSRRP provides that the aggregate number of common shares issuable thereunder and under all other security-based compensation arrangements of the Company at any time may not exceed 6.5% of the total number of issued and outstanding common shares from time to time.

### Stock Options

The Company has a stock option plan allowing for the granting of stock options to officers, employees and consultants of the Company. Stock options were granted periodically with a three-year vesting period. At the vesting, recipients have thirty days to exercise options after which any unexercised options expire. With the adoption and approval of the TSRRP, Peyto has ceased granting new awards under the stock option plan. Outstanding stock options will vest, exercise or expire according to original grant agreements.

### Deferred Share Units

Peyto has a deferred share unit ("DSU") plan, whereby DSUs may be issued to members of the Board of Directors. Each DSU is a notional unit equal in value to one Common Share, which entitles the holder to receive a common share upon redemption. DSUs vest immediately but can only be converted to a share upon the holder ceasing to be a Director of the Company. The expense associated with the DSU plan is determined based on the 5-day VWAP of Common Shares at the

grant date. The expense is recognized in the income statement in the quarter in which the units are granted, with a corresponding charge to contributed surplus in the balance sheet.

A substantial portion of the Company’s accounts receivable is with petroleum and natural gas marketing entities. Industry standard dictates that commodity sales are settled on the 25th day of the month following the month of production.

## 11. Financial instruments and capital management

### Financial instrument classification and measurement

Financial instruments of the Company carried on the condensed consolidated balance sheet are carried at amortized cost with the exception of cash and derivative financial instruments. There are no significant differences between the carrying amount of financial instruments and their estimated fair values as at June 30, 2026 except for derivative financial instruments.

The Company’s areas of financial risk management and risks related to financial instruments remained unchanged from December 31, 2025, except the Company's new contract with an embedded derivative as discussed below.

The fair value of the Company’s cash and financial derivative instruments are quoted in active markets. The Company classifies the fair value of these transactions according to the following hierarchy.

- Level 1 – quoted prices in active markets for identical financial instruments.
- Level 2 – quoted prices for similar instruments in active markets; quoted prices for identical or similar instruments in markets that are not active; and model-derived valuations in which all significant inputs and significant and significant value drivers are observable in active markets.
- Level 3 – valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable

The Company’s cash and financial derivative instruments have been assessed on the fair value hierarchy described above and classified as Level 1 and Level 2. Embedded derivative instruments have been classified as Level 3.

**Fair values of financial assets and liabilities**

The Company's financial instruments include cash, accounts receivable, accounts payable and accrued liabilities, dividend payable, long term debt and derivative financial instruments. At June 30, 2026 and 2025, cash and derivative financial instruments, are carried at fair value. Accounts receivable and current liabilities approximate their fair value due to their short-term nature. The carrying value of the long-term debt approximates its fair value due to the floating rate of interest charged under the credit facility.

**Commodity price risk management**

Peyto uses derivative instruments to reduce its exposure to fluctuations in commodity prices. Peyto considers all these transactions to be effective economic hedges for accounting purposes. Physical delivery contracts are not considered financial instruments and therefore, no asset or liability is recognized on the consolidated balance sheet.

#### Embedded Derivative

Peyto has a long-term agreement to deliver 50,000 MMBtu/d of natural gas for a term of 10 years, which delivery is expected to commence in 2029. Under the terms of the agreement, the Company will deliver natural gas at Alberta's Nova Inventory Transfer point and receive a Dutch Title Transfer Facility ("TTF") index price less associated deductions. Peyto has identified an embedded derivative within this contract as a result of the pricing structure, and the host contract is a natural gas sales agreement with an underlying AECO price. The Company recognizes gains (losses) on risk management contracts related to the embedded derivative. For the three and six month period ended June 30, 2026, the Company recognized an unrealized gain on the embedded derivative of \$6.5 million and \$6.5 million, respectively (2025: nil and nil). At June 30, 2026, the fair value of the embedded derivative was \$6.5 million (December 31, 2025, nil).

The Company's embedded derivative is classified as Level 3 within the fair value hierarchy as the fair value has been determined using a discounted cash flow which relies on significant unobservable inputs. The following details are the significant unobservable inputs used in the valuation of the embedded derivative agreement at June 30, 2026.
